**If space permits, 1 booth=\$250, 2 booths= \$500, 4 booths=\$750, 6 booths= \$1,000

One 110 volt electrical connection is furnished to each space. 220 provided at \$1.00 per amp.

20 daily tickets are included for entrance to the fair in order for you to man your booth. Additional tickets can be purchased for \$2.50 each.

Commercial building hours are 5 PM – 10 PM Weekdays
 1 PM – 10 PM Saturday & Sunday
