Insurance Requirements

The exhibitor is required to have the following insurance coverage, written by an acceptable insurance carrier, and provide the “Lake County Agricultural Society, Inc.” with an original Certificate of Liability Insurance prior to the set-up of exhibit. The policy effective dates must concur with the Lake County Fair dates.

The requirements are:

- \$1,000,000 General Liability Insurance and \$1,000,000 Product Liability Insurance, and/or completed operations if it applies. (Exception: “Information only” exhibitor is not required to have Product Liability but must have \$1,000,000 General Liability Insurance.)
- Workmen’s Compensation, if it applies, and
- The “Lake County Agricultural Society, Inc.” **and** “Lake County Board of Commissioners” must be listed as Additional Insured.
