# Soldier Memorial Planned for Lawn

The American Legion, with the cooperation of the community and the county commissioners, is planning a bronz honor roll memorial for the court house square. Architect Walker, who designed the court house, will be called in to plan the new project in keeping with the other building.

A bronz plaque will be installed of sufficient size to hold the name of all men and women from the county who are in the armed service during this war. This will require space for some two to three thonsand names. The project wil call for an initial expenditure of approximately \$1000.

Jess Benson, commander of he local Legion post, circulated a subscription list this week, raising \$700. He has another \$100 in sight and feels sure that there will be no difficulty encountered in raising the entire amount needed. The memorial will probably be erected on the south west corner of the square.

# Memorial to Lea Scounty Veterans

Jess Benson is putting in most of his time promoting the memorial to be erected on the Lea county court house lawn in honor of Lea county boys in the armed service. Every day the subscription to this fund is mounting and it is only a question of seeing all the people to having an ample fund to erect a fitting memorial.

Several years ago an organization was formed known as the American Womans Volunteer service. That organization has not been functioning for some time, and last week the members met and donated \$20.46 that was in the treasury to the memorial to be erected.

## Soldier Memorial Is Now Assured

The memorial to be erected on the court house lawn bearing the name of every one from Lea county in the armed forces is now assured.

This memorial is so arranged that names can be transferred from one list to another, so that in the final arrangement every name will appear in the proper place and this will stand as a lasting monument to the Lea county boys who fought that fredom should not perish from the earth.

#### Hobbs Organizes To Aid Memoiral

At a meeting of the various civic clubs of Hobbs last week, an agreement was reached to cooperate in raising funds for the Lea county memorial to our soldier boys to be erected on the court house lawn.

Committeemen selected to put on a drive at Hobbs were Jimmy Day, representing the American Legion and Lions club; Tom Mason, 20-30 club; Lyle Garner, Veterans of Foreign Wars; Dr. Allen P. Terrell and P. H. Golden, Rotary club.

This committee will work in conjunction with committees at Lovington, Jal, Eunice, Monument, Tatum and all of Lea county to finance, select and erect the honor roll memorial.

Jess Benson, who was the prime mover in geting this memorial under way, reported Monday of this week that \$1800 had been pledged. It is planned to raise \$3000 if possible so that the memorial will be fully paid for when completed. A list of all men and women from Lea county who served in the armed forces will be maintained on the memorial, the list of casualties specially designated and the lettering so arranged that it can be shifted when needed.

The American Legion of Lovington, which sponsored the memorial proposition, welcomes the help of the rest of Lea county and feels that with all cooperating in this move, a fitting tribute to those who serve can be erected. With organizations at Hobbs becoming actively interested, the memorial will soon be under construction, and all of Lea county can feel proud of this testimonial, just the same as they feel proud of those who are in the army, navy, air corps and marines.

A meeting of all American Legion I posts in Lea county to further plans for erection of the memorial has been called to be held in the Lovington Legion hall this Friday evening.

The Lovington Legion auxiliary will serve refreshments and all members of the auxiliary are urged to be present.

#### Memorial Drive Is County Wide

The meeting held at the American Legion hall in Lovington last Friday, evening for the purpose of organizing the Lea county war memorial was well attended and resulted in formation of an organization that will keep busy until all funds necessary for erection of a fitting memorial to the boys and girls who serve the colors of our country has been secured and the memorial is completed.

Jess Benson, as original booster and solicitor for the memorial, was fittingly made chairman of the organization, with Cliff Yearwood designated as treasurer. Committees were selected to attend to solicitation of funds in each community as follows:

Lovington, Benson, Yearwood and Sol Henry; Tatum, W. O. Dunlap and Lon Beadle; Hobbs, James Days, Dr. A. P. Terrell and Mr. Gholson; Monument, Tom Musick and Mr. Wagner; Eunice, R. C. Curry and Ray Garrison. Jal was not represented at the meeting but sent word it would line up 100 per cent and a proper committee will be selected later.

It was an enthusiastic meeting and all were optimistic in regard to the kind of memorial that should be erected. Benson reported that \$2100 had been secured and pledged for the memorial and practically all of it from Lovington and north. Dr. Terrell said that if a part of the county could raise \$2100 it should certainly be easy to push the fund to \$5000 with the rest of the county taking a hand. He made it a motion that \$5000 at the least should be secured for the memorial and immediately met with a second and a unanimous vote.

Fund Growing

Jimmie Day and Phil Golden of Hobbs got busy last week and collected \$1111.50 for the Lea county war memorial and they say that more will follow from Hobbs. # Unveiling of Lea County War Memorial Will Be Big Event of the Coming Week

The Lea county war memorial will be unveiled here next Tuesday. That being Memorial day, it is planned to have soldiers graves in the Lovington cemetery decorated, and that probably will be done during the morning hours, the Legion auxiliary of Lovington being in charge of that

The program for the unveiling will come during the afternoon, starting probably about 1:30. The HAAF band has been invited to participate in the afternoon and indications Tuesday were that the band would accept and furnish music for the occasion. The HAAF band is a good one and its music will be a treat for all present.

Jimmy Day of Hobbs will make the

presentation of the memorial to Lea county and it will be accepted by the county commissioners. Col. J. P. Bailey, commander at HAAF, has been asked to appear on the program. He has not stated positively whether he would be present, but he is expected to be represented by some other officer if he cannot attend.

Rev. Emmett Galolway, pastor of the Lovington Presbyterian church, will lead the singing of familiar patriotic songs, interspersed through program.

George S. Harris of Hobbs will act as master of ceremonies during the memorial dedication.

It is planned to have the various American Legion posts of the county represented on the program.

Most of the afternoon will be devoted to the unveiling program and all of Lea county is asked to attend and do honor to our armed forces.

There are more than 2000 names already placed on the memorial and it will reach 3000 eventually.

### Large Crowd Attends Dedication of Lea County War Memorial Tuesday

• A crowd estimated at 1500 to 2000 people was present for the unveiling of the Lea county war memorial here Tuesday. There were fully 1000 or more persons standing on the court house lawn and many were seated in cars around the square so the estimate of 1500 is thought to be an understatement of the attendance.

Dan Bodie of Hobbs had been slated as master of ceremonies when George Harris was called to Albuquerque on business. At the last moment pressing business prevented Mr. Bodie from attending, and Jimmy Day was pressed into service. Mr. Day is an ex-service man and he did a good job as master of ceremonies.

Rev. Emmett Galloway led in the singing of America and Onward Christian Soldiers. An enthusiastic crowd followed his lead and put pep! inot the singing. The invocation was given by W. M. Beauchamp, and commanders of the various American! Legion posts in the county were introduced by the master of ceremonies,

Mr. Day then introduced the speaker of the day, Col. J. D. Atwood of Roswell, who held the audience at close attention. Mr. Atwood is a veteran of world war No. 1 and is active in the work of the Legion. He said among other things that our duty to the dead is remembrance, and to see that the widows and orphans of our soldiers and sailors are cared for, but that we owe a greater duty to the living, and especially to those who served in the armed forces and that is to see that the country they fought to keep free is he same country they left when they entered the armed forces and has the same high ideal; that they are fighting to preserve the right to criticise as well as for our churches, our schools, our institutions and the right to earn a living, and that when they come home they will do some post war planning attend heard the program over their of their own and there is little plan-

ning we can do ere their return except to see that they have a job and are cared for. He drew applause many times during his remarks. He said our main duty here at home was to keep up morale and help win the war.

Chaplain Nelson C. Munson HAAF was present representing Col. Bailey and made a splendid short address, his subject of discourse being that men should be more regarded than material things, and that America, being a cosmopolitan mixture of nationalities, should do away with bigotry, with racial and class hatreds, declaring that this country has a heritage of religious background that has helped make its past and would safeguard its future.



# World War One Veterans Honored On War Memorial

Names of more than 150 war vets who served their country in time of war are to be added to the ever growing list of Lea Countians at the courthouse memorial.

Jess Benson chairman of the American Legion Memorial said 167 names of those who served from this area in World War II are to be added to the list of names on display.

These are names which Benson has traced down as having gone from what is now Lea County in 1917 and '18. The Chairman said these persons will be listed in less than 30 days. He also urges anyone whose name should be on the marker but is not to contact him at the courthouse. People who have relatives passed away but whose name does not appear should also contact Benson.
