A RESOLUTION APPROVING GRANT NO. G18SN0017A MODIFICATION NO. 2 BETWEEN LEA COUNTY AND THE OFFICE OF NATIONAL DRUG CONTROL POLICY DECREASING FUNDS FOR THE HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA) REGION VI AWARDED 01/01/2018 TO 12/31/2019

**WHEREAS**, Lea County is the fiscal agent for the Region VI Drug Task Force, which includes Administration, Lea County, Chaves County, Eddy County, Lincoln County and Pecos Valley; and

**WHEREAS**, for the grant period of 01/01/2018 to 12/31/2019, HIDTA was awarded a grant in the amount of \$400,261.00.

**WHEREAS**, on May 29, 2018, Modification No. 01 increased the grant in the amount of \$743,343.00 for a total awarded of \$1,143,604.00; and

**WHEREAS**, on July 13, 2018, Modification No. 02 decreased the grant in the amount of \$1,653.00 for a total awarded of \$1,141,951.00; and


**WHEREAS**, this grant has been decreased by \$1,653.00, requires acknowledgment and approval by the Board of County Commissioners; and

**BE IT FURTHER RESOLVED** the County Manager is authorized to finalize and sign the application and grant documents consistent with the terms of this resolution.


