THE LEA COUNTY PLANNING & ZONING BOARD WILL HOLD A REGULAR MEETING & PUBLIC HEARING FOR ROAD AND LAND VARIANCES ON TUESDAY, FEBRUARY 12, 2019, AT 9:30A.M. AT THE LEA COUNTY COMMISSION CHAMBERS, LEA COUNTY COURTHOUSE, 100 N. MAIN, LOVINGTON, NM.

CLAYTON DAVIS AND DANIEL TORRES ARE REQUESTING A ROAD VARIANCE TO ALLOW A LESS THAN 60-FOOT WIDTH ROAD DEVELOPMENT AT THE CORNER OF FOWLER STREET AND LOVELADY ROAD TRAVELLING NORTH TO ALEGRE STREET.

CHRIS ARMITAGE IS REQUESTING A MINIMUM LOT SIZE VARIANCE FOR THE COMBINATION OF LOT 4 AND LOT 5, BLOCK 11, KNOWLES SUBDIVISION, SECOND UNIT INTO A LOT OF LESS THAN ONE ACRE. THE SITE IS IN THE 700 BLOCK OF MARTIN AVENUE, EAST OF GRIMES STREET AND WEST OF COCHRAN STREET. APPROXIMATELY THREE-QUARTERS OF A MILE NORTH OF MILLEN DRIVE AND ONE-QUARTER MILE SOUTH OF COLLEGE LANE.

HILDA REITHBAUM IS REQUESTING A MINIMUM LOT SIZE VARIANCE FOR THE DIVISION INTO LOTS OF LESS THAN ONE ACRE OF LAND. THE SITE IS AT 425 WEST SOCKWELL, ONE BLOCK NORTH OF MILLEN ROAD AND A ONE-QUARTER OF A MILE EAST OF GRIMES STREET.
