### NOTICE OF PUBLIC HEARING AND CONSIDERATION OF ADOPTION OF AN ORDINANCE

The Board of Commissioners of Lea County, New Mexico (the "County") will consider the adoption of an ordinance (the "Ordinance") on July 25, 2019, at 9:00 a.m. or as soon thereafter as the matter may be heard, at the Commission Chambers, Lea County Courthouse, 100 N. Main, Lovington, NM 88260. The title and subject matter of the proposed Ordinance are as follows:

**DANGEROUS BUILDINGS ORDINANCE.** The Ordinance will apply only within the area identified as the Lea County/Hobbs Extraterritorial Area which is a five-mile wide band around the municipal boundaries of the City of Hobbs. The Ordinance regulates the abatement, removal, and condemnation of dangerous or dilapidated buildings, premises, or structures, including mobile homes and manufactured homes.

Copies of the Ordinance are on file in the office of the County Clerk and will be available for inspection during normal business hours. The County Clerk's office is located at the Lea County Courthouse, 100 N. Main, Lovington, NM 88260.
