1.Applications available at the Lovington Chamber of Commerce or website www.lovingtonchamber.org.

- A. All parade entries must be returned by Monday August 5, 2019 at 5:00pm
- B. Entry received after the deadline will be placed at the end of the lineup, this includes additional company vehicles added late.
- C. Liability waiver must be received by all participants. If members of a group that have previously signed waivers, this will apply.
- D. If your liability waiver is **not** received you will **not be** allowed to participate.

2.Parade check- In:

- A. Will take place at the Lovington High School Stadium parking lot located at South 9th Street
- B. Entries may start checking in as early as 2:00pm. **All participants must be on float at stadium.** The parade leaders will have your assigned spot and ticket.
- C. All Parade entries must have filled out a form and signed the liability waiver.
- D. The parade line-up will be heading North on 11th Street between Ave K & D.
- E. All bands will unload at Ave D Park in Lovington.
- F. Horse entries, stagecoaches, wagons, etc. must assemble in the vacant lot W of Bobs @ 3:30pm.
- G. All entries must be checked in by 3:30pm, in line and ready to go by 3:45pm. Anyone late Checking in or late entries **will be** placed at the end of the parade.

3.Judging:

- A. Only entries that mark they want to be judged on their entry form will be judged.
- B. Extra points will be awarded for floats that have unique float look.
- C. All judging will take place during the parade route.

4. Parade Route:

- A. Will head North of 11th street, turn right on Ave D. traveling East and turn left on Main Street, and traveling North on Main to Jefferson where the parade ends.
- B. Once entries turn left on Jefferson, the entries may disperse. **Please note: you must not speed back to stadium!! Safety is #1 Priority!!**

PARADE RULES

1. All entries will comply with Parade Rules or be subject to immediate dismissal from parade.
2. **ABSOLUTELY NOTHING WILL BE THROWN OR HANDED TO PARADE WATCHERS FROM ANY PARADE ENTRANT (YOU MAY NOT EVEN HAD OUT WHEN WALKING).** This will be justification for immediate dismissal and the entrant will be barred from all future parades. **This is a liability for not only your business, but Lea County, NM, and the Lovington Chamber of Commerce.**
3. All motorized vehicles will be driven by a licensed driver. Proof of license and insurance may be required to be shown to parade officials.
4. Any high-performance vehicles will be on a trailer designated to haul or you may tow it if battery is removed or disabled from being able to run under own power.
5. **All entries are limited to a vehicle and a trailer, not more than sixty (60) feet in total length, fourteen (14) feet in width and twelve (12) feet in height.**
6. Any entry that is considered an ATV (4 or 3 wheelers) or motorcycle that will be driven by someone under the age of 18 requires a parent passenger and signature on the liability waiver.
7. Any driver 16 years and under must have parental supervision before, during and after the parade. NO passengers allowed unless parents are riding with the young drivers. This will be an immediate dismissal and any future entries barred from all future parades.
8. Parade officials will not provide cars, horses or transportation of any kind.
9. The parade officials reserve the right to reject any entry for any reason.
10. The parade officials reserve the right to re-classify any entry.
11. The parade Officials reserves the right to set the lineup for ALL entrants in the parade.

RELEASE OF LIABILITY- READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the Lovington Chamber of Commerce and Lea County Fair & Rodeo program and its related events and activities,

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while skills, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation and,
3. I willingly agree to comply with the terms and conditions for participation as determined by Lea County. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the County immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Lea County, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity("Releases"), FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs and next of kin FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OF RESULTING IN DEATH OF THE UNDERSIGNED OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE.
5. I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releases and each of them FROM ANY LOSS, LIABILITY DAMAGE, OR COST they may incur arising out of or related to the EVENT(S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE.
6. I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASE or otherwise.
