Effect of Signature: By signing this application and submitting it, the contestant represents and agrees that (1) all facts and representations contained in this application and contract and its attachments are true and accurate; (2) the contestant agrees to abide by all rules and regulations of the Lea County Fair Board described in this application and its attachments in the period before and during the year of service; (3) the contestant meets each requirement for eligibility set forth in the regulations and (4) the Lea County Fair Board shall have the sole discretion to determine whether, in its judgment, the contestant may continue to participate in the program. In the event that the Lea County Fair Board determines that any statement or representation by the contestant is not true and accurate or that any action by the contestant is inconsistent with the rules and regulations of the program; (5) other than minor, petty or traffic offenses, the contestant has never been convicted of any offense and there are no criminal charges presently pending against the contestant; and (6) the contestant does not use or consume any illegal controlled substances or engage in the illegal use of alcohol. Contestants will not be allowed to curse, smoke, drink alcoholic beverages, or be under the influence of narcotics at any time after their application is received. Any unsatisfactory behavior will be cause for dismissal of the contestant and relinquishment of title and/or any awards.
