

RESOLUTION AND PROCLAMATION

WHEREAS, the Board of Trustees of Jal Hospital District of Lea County, New Mexico, has determined to submit to a vote the question of a special tax levy in the amount of THREE DOLLARS (\$3.00) on each ONE THOUSAND DOLLARS (\$1,000.00) of the net taxable value, as defined in the Property Tax Code (Session 7-35-1 through 7-38-93 N.M.S.A., 1978, as amended), of all property within such hospital district under the Special Hospital District Act and for the purpose hereinafter specified, as provided by Session 4-48A-16,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Jal Hospital District of Lea County, New Mexico, which constitutes the governing body of such district in the County of Lea, State of New Mexico:

Section 1: A regular election shall be held on Tuesday the 5th of November, 2019, at which time the Jal Hospital District Trustees shall submit to all voters in the District the following question:

“Shall the Jal Hospital District of Lea County, New Mexico impose a Property tax of THREE DOLLARS (\$3.00) on each ONE THOUSAND DOLLARS (\$1,000.00) of net taxable value, as defined in the Property Tax Code, on all taxable property of the county within such Hospital District for the property tax years 2020, 2021, 2022 & 2023 for the use of current operation and maintenance of the Hospital District or for the clinics operated and maintained by the Special Hospital District pursuant to an agreement with a political subdivision as provided in Section 4-48A-11.B, N.M.S.A. 1978, as amended, of the Special Hospital District Act, and to pay the operational cost of the Special Hospital District?”

Section 2: A person is a qualified elector of the District if he or she resides in the District, is a citizen of the United States, and at least eighteen years of age on the date of the election.

Section 3: Voter registration for this election closes at 5:00 p.m. on October 8, 2019.

Section 4: Absentee voting shall be permitted as authorized by Section 1-22-19 and 1-6-1 through 1-6-18, N.M.S.A., 1978, as amended. Absentee applications may be obtained from the Lea County Clerk's Office. Absentee voting will be held from Tuesday, October 8, 2019 through Friday, November 1, 2019 in the Lea County Clerk's Office in the Lea County Courthouse, 100 North Main, Lovington, New Mexico during normal business hours.

Section 5: The polls shall be open between the hours of 7:00 a.m. and 7:00 p.m. on Election Day, Tuesday, November 5, 2019.

Section 6: The boundary line of the Jal Hospital District is identical with the school district of Jal, New Mexico and all voters eligible to vote in that school district are eligible to vote in this election. Precincts in the Jal Hospital District are part of precincts 71, 73 and 74. Jal City Hall, 309 Main Street, Jal, New Mexico will be the polling place.
