#### STATE LAW

Pursuant to Section 7-36-21 NMSA, all livestock located in the State of New Mexico on January 1st of the tax year shall be valued for property taxation purposes as of January 1st. All livestock brought into the state and located there for more than twenty days subsequent to January 1st shall be valued for property tax purposes as of the first day of the month following the month in which they have remained in the state for more than twenty days. The owner of livestock subject to valuation for property taxation purposes shall report the livestock for valuation to the county assessor of the county in which they are located on the valuation date specified. Any person who intentionally refuses to make a report required of him under this section or who knowingly makes a false statement in a report required under Section 7-36-21 is guilty of a misdemeanor and shall be punished by the imposition of a fine of not more than one thousand dollars (\$1,000). Any person who fails to make a report required of him under this section is liable for a civil penalty in an amount equal to five percent of the property taxes ultimately determined to be due on the property for the tax year or years for which he failed to make the required report .
