



84th ANNUAL LEA COUNTY FAIR AND RODEO 4-D Barrel Race presented by LCBRA Monday, August 5th, 2019



DRESS CODE ENFORCED: NBHA rules and dress code apply; Contestants appearance must be neat, clean and professional. Any contestant whose appearance is deemed unprofessional will receive a **NO TIME**. Contestants must wear long sleeve shirts that are collared and have either buttons, snaps or a full-length zipper on the front of the shirt. Jeans without holes, western boots and western hat (helmets are acceptable for all competitions) must be worn for all rodeo performances and slack.

1. **Mailed entry deadline is Monday, July 15, 2019. NO EXCEPTIONS and NO postmark dates will apply or be accepted. Must be received to LCBRA 4008 N. Grimes PMB 105 Hobbs, NM 88240.**
2. **Online entries will be accepted at www.ebarrelracing.com through Monday, July 29, 2019 at 12:00 PM (noon).**
3. **There will be NO ONSITE ENTRY AND NO LATE ADDS OR CHANGES**
4. **DRAW WILL BE POSTED BY END OF DAY THURSDAY, AUGUST 1, 2019.**
5. Entry form, signed release of liability, and payment must be received before entry is accepted as complete. Minors must have release of liability signed by parent. Forms are available on the Lea County Fair website, Lea County Barrel Racing Association (LCBRA) Facebook Page and on ebarrelracing.com.
6. A \$35.00 returned check fee will be charged on all returned checks. Personal checks are accepted by mail until the July 15th deadline ONLY.
7. Contestants may enter up to 4 different horses. A horse may only be entered one time and cannot be ridden by two different people.
8. VET/DOCTOR RELEASE will be accepted until August 2, 2019 at 12:00 pm. Please email **lcbra1984@yahoo.com and call 575-441-5954.**
9. Failure to enter the arena within the first 3 gate calls will result in a **NO TIME**.
10. Contestants must keep a forward motion, no circling in the arena or alley.
11. Contestants will receive a **NO TIME** for knocking over a barrel or breaking the pattern. If a rider circles a barrel more than one time they will receive a \$50 fine, strictly enforced.
12. Absolutely **NO** switching of draw positions. It is the contestant's responsibility to know their horses' draw position. Contestants switching draw positions on their horses will receive a **NO TIME**. If a contestant runs out of turn; they will receive a **NO TIME**.
13. Payout will be completed at the end of race and each PRCA performance. **Winner(s) must fill out a W-9 and must show driver's license to pick up winnings at the end of the barrel race.**
14. The top 5 from each division will perform on their designated night during the PRCA Rodeo Performance at 7:00 pm as follows:

4D – Wednesday, August 7, 2019

13. **Each contestant eligible for the PRCA performance must confirm at the conclusion of the Open 4D race if you will run.** If contestant does not run in PRCA performance, the next winning placing will be moved up.
14. Monday night race payout will be regular race payout of 80% and buckles to each D winner. Buckles donated by Kountry Korral.
15. Short go/Performance payouts will be \$500 and a buckle to the winner of each performance (Wed-Sat). Buckles donated by Bootsies.
16. Open 4D Barrel Race is a random computer draw. LCBRA, in conjunction with the Lea County Rodeo Committee, reserves the right to draw positions for PRCA performance. If PRCA performance is not drawn, then run order will be in reverse order from Open 4D placings.
17. Inclement weather: Lea County Emergency rules pertain: If lightening is within less than 5 miles of facility, delays will be in 30-minute increments until cleared or notified to cancel and reschedule. If Barrel Race is cancelled and rescheduled due to inclement weather or safety issues, every effort will be made to coordinate with Lea County Fair personnel to reschedule around all other events already scheduled. Draw outs allowed due to inclement weather will be refunded, **entry fees only**, if Barrel Race personnel are notified by deadline set at time of cancellation or rescheduling. Money will not be figured in payouts. If draw out after inclement weather designated deadline, no refund will be made, and money will be figured in payouts. Every effort will be made to ensure contestants know draw out deadline due to inclement weather at time of cancellation.
