

## Official Rules

### Terms, Conditions and Rules (the "Rules") for Online Sweepstakes (the "Promotion")

This Promotion is governed by the laws of the Texas, and all claims must be resolved in the federal or state courts located in Texas. You are not authorized to participate in the Promotion if you are not located within the United States.
