Signing up to Mutton Bust will be a little different in 2018! Below is information about how you can Mutton Bust at the Lynden PRCA Rodeo and/or during the Northwest Washington Fair Grandstand Horse Show.

LYNDEN PRCA RODEO

- ❖ Mutton Busting applications are available on the Lynden PRCA Rodeo Facebook Page and in the Northwest Washington Fair Office.
- ❖ Mutton Busting will take place at the rodeo on Tuesday, August 14th and Wednesday, August 15th.
- ❖ Contestants must weigh 50 pounds or less and will be required to step on a scale at check in.
- ❖ Helmets will be provided.
- ❖ The deadline to sign up is Friday, August 10th, by 4:30 p.m. in the Northwest Washington Fair Office.
- ❖ Contestants will be contacted no later than Monday, August 13th to confirm time and meeting location.
- ❖ Admission to the Rodeo is FREE for children 10 and under, but any accompanying adults must have Rodeo admission tickets.
- ❖ Additional information is available on the application.

NORTHWEST WASHINGTON FAIR GRANDSTAND HORSE SHOW

- ❖ Mutton Busting will take place during the Grandstand Horse Shows on the following dates and times:
 - Tuesday, August 14th – 12:00 p.m.
 - Wednesday, August 15th – 12:00 p.m.
 - Thursday, August 16th – 12:00 p.m. and 5:00 p.m.
 - Friday, August 17th – 12:00 p.m. and 5:00 p.m.
 - Saturday, August 18th – 12:00 p.m.
- ❖ Registration will happen DAILY at the Mutton Busting tent outside of the Grandstand Arena.
- ❖ Contestants will be taken on a first come, first served basis.
- ❖ Sign-up for the 12:00 p.m. show between 10:00 a.m. and 11:00 a.m.
- ❖ Sign-up for the 5:00 p.m. show between 3:00 p.m. and 4:00 p.m.
- ❖ Helmets will be provided.
- ❖ Contestants must weigh 50 pounds or less and will be required to step on a scale at check in.
