

## \* BREEDING HEIFER SHOW RULES AND REGULATIONS \*

\*Entries open August 6th

\*Entries close August 31st

\*Video due at time of entry.

\*Judging will be the week of September 14<sup>th</sup>

1. Exhibitors in 3<sup>rd</sup> grade or 9 -18 years of age by January 1, 2020. All exhibitors will be allowed to show the animals that they had declared for the New Mexico State Fair.
2. There is no limit on number of entries allowed.
3. This is a NON fit show. Fitting Regulations are as follows: Absolutely NO artificial coloring, glues or adhesives will be allowed.
4. Breeding heifers will be classified and shown by age. Registration papers are required. Your registration number and DOB will be required at time of entry.
5. Any animal not having a legible tattoo is ineligible to compete in the breed classes but can be shown in A.O.B. (All Other Breeds).
6. If you are showing an **unregistered** breeding heifer you will be required to enter the NMSF tag number of each heifer you enter. A photo of your NMSF tag and animal must be uploaded with your entry.
7. In the event that not enough heifers are shown, breeds may be combined at the discretion of superintendent.
8. Breeding Heifer divisions offered at the New Mexico State Fair are as follows and a Champion and Reserve will be selected in each of the following breeds. Those breed Champion and Reserves will then show for Supreme Heifer and Reserve Supreme Heifer of the show:

## **American Aberdeen**

**Heifer calved on or after September 1, 2018**

## **Angus**

## **Brangus**

Brangus entries are subject to the provisions of the IBBA "Eligibility and Inspection of Exhibits." No cattle should be allowed to be shown that do not have actual registration papers or copies of original papers in hand by show day.

Youth exhibiting heifers must be member of AICA. Any animal not having a legible tattoo or firebrand number is ineligible and will be barred from showing.

## **Limousin**

North American Limousin Foundation requires that all animals be registered, properly tattooed and will be inspected at the show. Cattle must be entered in the exact same name that appears on the registration certificate as the current owner.

Animals entered must be registered with the American Maine Anjou Association as owned or leased in the name of the junior exhibitor and carry a legible tattoo.
