Check-in at 6pm @ Anderson County Courthouse. Parade begins at 7pm.

We hope you enjoy being a part of this special event and will participate for years to come!

Check-In: Check-in will be at the corner of Church and Crawford beginning at 6pm.
Check-in is required for all participants.

Route: The parade starts at the Anderson County Courthouse, and proceeds to Avenue A, to Main Street turning right onto Queen Street, then right on Crawford Street and returning to the Court House.

Awards: To qualify for awards, participants must submit the Christmas Parade of Lights Application no later than 12pm on Friday November 30, 2018. 1st, 2nd, and 3rd place trophies for best entries will be awarded in the following three (3) categories: Band/Organization, Individual, and Business. First place for each category will also receive a \$100 prize. Entries will be judged on theme, presentation of lights, and overall appearance.

Awards Presentation: Awards will be presented at the Anderson County Courthouse steps following the parade. Floats will be directed to a designated parking area. The Court House will be lit for the Holidays, and Santa will be on hand to visit with the children.

Identification: Participants are required to identify their entry with:

- A 22" x 24" sign affixed to the driver's side of the entry, which includes the name of the individual, organization or business.
- A detailed description of the entry on the Christmas Parade of Lights Application.

Rules:

- No Life-Like Santa Claus will be allowed on any float.
 - The City will provide an official Santa Claus for the parade.
- A copy of current insurance must accompany the completed application!
- All entries must feature Christmas lights.
- Horses must be bagged.
- The theme "Christmas in Toyland" must be incorporated into the entry to be eligible for judging.
- All accepted participants must sign the waiver on the application and return it with insurance.
