1. All entrants are required to identify their entry by a) providing a detailed description on their parade entry form and b) affixing a 22" X 24" sign on the right side of the entry, that includes the name of the individual, organization or business.
2. All accepted participants must sign the enclosed waiver and return the application as instructed in the opening paragraph of this form document.
3. A copy of a current driver's license and insurance must accompany the application for all moving vehicles.
4. Moving vehicles are not allowed to demonstrate excessive out of line movement.
5. Current Coggins papers for equine entries must be presented at parade sign in.
6. Mystics of Time Mardi Gras Society reserves the right to restrict, limit, accept or reject any application.

I have read the attached general rules and regulations regarding the Mystics of Time Mardi Gras Parade and agree to comply. Further, I realize the purpose of the parade is to provide community fun and entertainment to our local citizens. The Mystic of Time Mardi Gras Society reserves the right to approve or deny entry to the parade.
