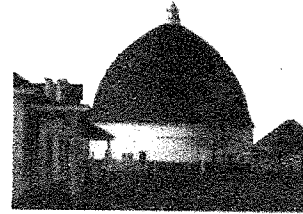

4. The Plymouth County Fair **will have Wi-Fi available.**

**EXHIBITOR AGREES TO: TIMES ARE SUBJECT TO CHANGE**

1. Have exhibit set up and ready to show by 12:00 p.m. Wednesday, July 24, 2019.
2. Open display by 12:00 p.m. and remain open until 10:00 p.m. Wed. – Sat. Open Sunday at 1:00 p.m. and remain open until 7:00 p.m. **DO NOT REMOVE DISPLAY UNTIL AFTER 7:00 P.M. ON SUNDAY, July 28, 2019.**
3. The exhibitor agrees to the following concerning liability. The Plymouth County 4-H and Agricultural Society, (Plymouth County Fair), expressly refuses to assume any liability for injuries to any person or damage to any property coming upon the grounds of the Plymouth County Fair and no claims for injury to any person or damage to property shall be asserted or suit instituted or maintained against the said Plymouth County 4-H and Agricultural Society, it's officers, agents, or employees for said cause by any person having privilege to exhibit or license to operate on the fairgrounds or occupying any space thereon. And it is a part of the consideration for each license or privilege granted by the Plymouth County Fair that such claims for injury or damage to property are specifically waived.
