## MUTTON BUSTIN'

### 2019 RIO GRANDE VALLEY LIVESTOCK SHOW



1. A Mutton Bustin' event will be held in connection with the rodeo performances at the 2019 Rio Grande Valley Livestock Show as follows:
  1. 7:30 pm – Saturday, March 9
  2. 4:00 pm – Sunday, March 10
  3. 7:30 p.m. – Wednesday, March 13
  4. 7:30 pm – Thursday, March 14
  5. 7:30 pm – Friday, March 15
  6. 7:30 pm – Saturday, March 16
2. Contestants will be required to pay a **\$20.00 entry fee (Money Order or Check, No Cash please)**, which must accompany entry application.
3. The number of contestants will be limited to 12 per rodeo performance.
4. **Contestants must be 4 to 5 years of age as of March 1, 2019 and not weigh over 45 pounds. (Weight may be verified at performance time.)**
5. All contestants will be awarded trophies. The first place contestant in each of the six rodeo performances will also receive a belt buckle.
6. For safety sake, contestants will be required to wear headgear. Some will be available at the rodeo or a participant can bring his or her own.
7. Application & Release Form must be signed by a parent or Legal Guardian and returned to the Livestock Show Office by Friday, February 15, 2019.
8. All contestants who submit entry applications will be advised by mail as to whether or not they were selected and if selected, during which rodeo performance they will participate.
9. Each contestant will be sent two complimentary gate tickets. One for the contestant and one for a parent or guardian.
