

Rockingham County Fair Social Media Promotions Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

1. **Eligibility:** Social media promotions conducted by Rockingham County Fair Association, Inc. are open only to those who participate on applicable social media platforms. Must be 18 years old or older as of the date of entry. The Promotions are only open to legal residents of the United States and are void where prohibited by law. Employees of Rockingham County Fair Association, Inc., its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Promotions. The Promotions are subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. **Agreement to Rules:** By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decisions of Rockingham County Fair Association, Inc. as final and binding as it relates to the content of any Promotion.

If Winner cannot be contacted, is ineligible, or fails to claim the prize according to the instructions provided, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Promotion is conditioned upon compliance with any and all federal, state, and local laws and regulations.
