

Santa Maria Fairpark

RV Camping – Terms & Conditions

Fees:

- RV Site: \$45 per night
- Extra Vehicle/Trailer (limit 1 per reserved site): \$20
- Dumping: \$20
- Reservation: \$10 per transaction

Check-In & Check Out Time:

- Check-In 3:00 PM – PLEASE display reservation confirmation on dashboard on drivers' side of RV.
- Check-Out 12:00 PM – PLEASE cleanup & remove all debris from your camp site.
- The front desk may be able to arrange an early check-In or late check-out, depending on availability. Additional fees may apply. Call 805-925-8824.

Occupancy Guidelines:

- Campers: Maximum of 4 guests per site.
- Visitors: Up to 6 visitors are welcome per site during non-quiet hours (Quiet Hours 10 PM – 8 AM).

Pet Guidelines:

- Pets are welcome and must be registered at time of reservation. Maximum of 2 pets permitted.
- Guests should carry proof of pet's current vaccinations.
- Guests are responsible to "clean up" after their pet. All pet droppings must be properly disposed of in a trash receptacle.
- Pets must be kept on a leash (maximum 10 ft.) and are not permitted inside buildings.
- Pets are not to be left unattended at any time.
- Fairpark is not responsible for, and will hold pet owner accountable for, any injury or damage caused by pet(s).

Parking Policy:

- All RV's, vehicles and trailers must have current license and registration.
- Site availability is first come/first available. No reserving a specific site. Please refer to site sizes on RV Camping Map and park your RV in the proper size site so you do not have to be relocated.
- One RV is allowed per site and must be parked completely on the site. One extra vehicle is permitted (subject to availability) per site for an additional \$20. Display receipt in dash.
- All RV'S must be self - contained, no tent camping.

Things to Keep in Mind:

- Please be prepared with the following, extra long sewer hose & power cords as some of the hookup ups are located further away from where RV's are parked. Leveling blocks, not all sites are level.

Security:

- Management is not responsible for lost, stolen, or damaged articles. Keep valuables locked up.

Quiet Hours:

- Quiet hours are from 10:00 PM to 8:00 AM. Generators may not be used during these hours.
- Please be courteous to other guests around you. Inconsiderate guests will be asked to leave.
- Loud, objectionable noise is not allowed at any time.

Park Policies:

- Observe the speed limit of 5 MPH, do not park in undesignated areas.
- Working on, or storing of, any vehicles is prohibited. NO dumping of excessive materials or trash.
- No fires allowed. Fully contained BBQ grills and camping stoves are permitted.
- Drugs, weapons, fighting, lewd conduct, reckless driving not permitted at any time.
- Smoking is prohibited in all indoor facilities and within 25 feet of any building.
- Motorized/non-motorized scooters and skateboards are not permitted.
- Profanity or violence towards others and the park team will not be tolerated.
- Report any problems with your site to the Fairpark immediately. Call 805-925-8824.

Reservation Limits:

- Campers may stay up to a maximum 30 consecutive days per visit. There must be a break of 30 days between visits with a maximum of 60 days per calendar year.

Cancellations/Refunds:

- Requests for full cancellations must be made in writing within 7 days of arrival date.
- Requests for partial cancellations may be made up to 48 hours prior to arrival date but will forfeit the fees of 1-night stay.
- All cancellations/refunds are subject to \$35 Administration Fee.

Adhering to Terms & Conditions:

- The Terms & Conditions must be adhered to, as well as any other directions given by the Santa Maria Fairpark. Any violators of the above policies will be asked to leave the property without refund of fees. Fairpark Management reserves the right to close the campground, either partially or entirely without notice.
- Pursuant to the CA Recreational Vehicle Occupancy Law, A "RECREATIONAL VEHICLE MAY BE REMOVED AS SPECIFIED IN SECTION 799.99 FOR FAILURE TO PAY OR FAILURE TO COMPLY WITH PARK CAMPING POLICY." CA Civil Code Sections 799.22, 799.43 and 799.58.
