### **Guidelines**

**Deadline – Friday, April 3, 2020**

#### *Appearance Guidelines*

---

1. **Grooming:** This includes neatness and cleanliness.
2. **Photogenic Quality:** Judges will conduct a review of a single digital photo that the contestant will have submitted with his entry.
3. **Posture:** How a contestant carries himself is important.
4. **Rodeo Clown:** Contestants should pick outfits that resemble rodeo clowns.

#### *Personality Guidelines*

---

The purpose of this category is to select the young man who rates the highest in:

1. **Conversational Ability:** Speaking ability in varied circumstances is essential.
2. **Humor and Enthusiasm:** A good sense of humor and enthusiasm is critical. Should be prepared to share jokes.
3. **Self-Esteem and Morals:** High Self-confidence, moral standards, sincerity, and integrity should be exhibited.
4. **Consideration of others:** Contestants should have a genuine interest in other people and consideration of others.
5. **Positive Outlook:** A happy outlook on life and general positive attitude is necessary.
6. **Interview Ability:** Promptly and correctly answer the interview questions.
7. **Speaking Ability:** Give an appealing and informational one (1) minute speech on why you want to be the Santa Maria Elks Rodeo Jr. Barrelman.
8. **Exhibit your personality.**

#### *Athleticism Guidelines*

---

The purpose of this category is to select the young man who rates the highest in:

1. **Agility:** Control and ability to maneuver efficiently in, out and around objects.
2. **Endurance:** Can walk, run, etc. for extended periods of time.
3. **Stability:** Can walk, run, etc. on uneven surfaces, such as sand or dirt.
4. **Strength:** Able to climb into barrel (assistance will be provided).



## *Judging Guidelines*

---

The Santa Maria Elks Rodeo Jr. Barrelman Competition will use the following procedures for judging:

1. At least three (3) Judges will be used to judge all categories. Judges will be selected based on their expertise in the various categories.
2. Judging will cover three categories: Appearance, Personality and Athleticism.
3. Decisions by the Judges are final!
4. Scoring ties for each category (Appearance, Personality, and Athleticism) will be broken by referring back to the score of Judge #1. That score will break the tie. If a tie still remains, the score of Judge #2 will be used... and so on until the tie is broken.

## *Photo Guidelines*

---

1. Provide one (1) color digital photograph with 300 dpi. If submitting a hard copy of the application packet, please, email a photo AND include a 4x6 photo in your application packet.
2. The photos should be a head and shoulder shot in rodeo clown attire.
3. The photo submitted will be used by the Elks Recreation, Inc. to promote the Santa Maria Elks Rodeo and Elks Recreation, Inc.
4. Submitted photos and any subsequent pictures taken in connection with the competition in any manner are the property of the Elks Recreation, Inc. and may be used for promotional purposes without written consent of the contestant.

## *Autobiography Guidelines*

---

Every contestant is required to submit one (1) autobiography with his application. The following guidelines are to be used in composing your autobiographies. Your autobiography will be used for public relations activities and print media and should be 75 - 100 words. This autobiography should be in third person and contain the following:

1. Information on your place of birth and where you live.
2. School, church, or other activities.
3. Personal successes.
4. Reason for your interest in Santa Maria Elks Rodeo Jr. Barrelman.
5. Why you have chosen to compete for the title of "Santa Maria Elks Rodeo Jr. Barrelman."
6. Any particular story of interest that may relate to rodeo or your desire to be the "Santa Maria Elks Rodeo Jr. Barrelman."

This autobiography may be used in print media and public relations material for the Elks Recreation, Inc. The Elks Recreation, Inc. retains editorial jurisdiction over content. Any written materials you provide may be modified to fit public relations guidelines.
