This release covers all claims, known or unknown. The purpose of this release is if I, my child, my horse, and/or my property is injured, damaged, or becomes ill, I, my child and my legal representatives, heirs, assigns and estate cannot make claims for those damages, injuries and illnesses.

By signing this release, I grant the Elks Recreation, Inc., G Lazy T Livestock, Santa Maria Elks Lodge #1538 and the operators of its activities and events, their employees, agents, and assigns, my permission to initiate emergency first aid treatment for myself or my child in the event such treatment is reasonably required, which determination may be made at their discretion.
