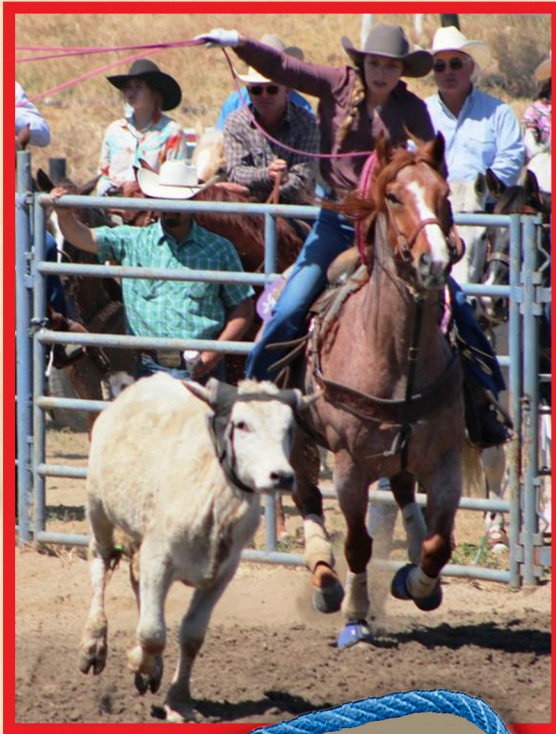

For ourselves and for participant we waive the provisions of **California Civil Code section 1542** which reads:

A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release which if known by him or her must have materially affected his or her settlement with the debtor.

This release covers all claims, known or unknown. The purpose of this release is if I, my child, my horse, and/or my property is injured, damaged, or becomes ill, I, my child and my legal representatives, heirs, assigns and estate cannot make claims for those damages, injuries and illnesses.

By signing this release, I grant the Elks Recreation, Inc., G Lazy T Livestock, Santa Maria Elks Lodge #1538 and the operators of its activities and events, their employees, agents, and assigns, my permission to initiate emergency first aid treatment for myself or my child in the event such treatment is reasonably required, which determination may be made at their discretion. I also grant permission for my child to be photographed and for these photos to be used for promotional purposes.

I agree and understand this agreement is intended to be as broad and inclusive as permitted by the laws of the State of California, and if any portion of this agreement is invalid, it is agreed the remainder of this agreement shall continue in full force and effect.
