**2021 Silver Dollar Fair Market Goat, Hog & Lamb Exhibitor Requirements:**

- **SUBMIT ENTRY FORM & \$15.00 ENTRY FEE BEGINNING 8:00 a.m. JANUARY 4, 2021 through 5:00 p.m. MARCH 29, 2021 as per Entry Lottery information below. Entry fee is non-refundable. \$15.00 processing fee for each backup animal entered is non-refundable.**

- **Online entries must complete the Livestock Liability Waiver & submit (mail or email) for entry to be valid.**

**▶ 2021 ENTRY LOTTERY RULE ◀**

- **Market animal entries will be limited to 45 steers, 270 hogs, 210 lambs & goats combined, and 40 rabbit meat pens.**
- Entries will be received by the Fair Office between the entry opening date specified in the local rules and close of entries, which is the ownership deadline as specified in State Rules.
- If at 12:00 noon on the 5<sup>th</sup> business day after entry opening, there are more market animal entries than the limit allows (for a specie), the Fair shall institute a public lottery to select the specified number of entries allowed from all entries for each specie, received from the beginning of entry opening.
  - This public lottery will take place at 4:00 p.m. on the 5<sup>th</sup> business day after entry opening in the Fair Administration Office and shall be open to any interested party to witness.
  - Entries not selected in the lottery for participation in the market animal show will be entered into a secondary lottery to rank a waitlist order
- Any entry submitted after 12:00 noon on the 5<sup>th</sup> business day after entry opening will be accepted if entry limits for that specie have not been exceeded. If entry limit has been reached entries will be placed on the waitlist in order of receipt by the Fair Office, behind entries that were received in the Fair Office prior to 12:00 noon on the 5<sup>th</sup> business day after entry opening.
- If an entry that was selected to participate in the market animal show withdraws for any reason, entries from that specie waitlist will be selected to participate in the Market Animal show based on rank order.
- Entry fees are due when entry form is submitted.
- If an exhibitor is not selected to participate in the market animal show as a result of the lottery process, the entry fee will be refunded upon request.
- **SUBMIT PROOF OF OWNERSHIP NO LATER THAN 5:00 p.m. MARCH 29, 2021 (60 days prior to the opening day of Fair as required by State Rules). *Independent Exhibitors: see requirements in Local Rules &/or Independent packet.* **Photo(s) must be submitted & approved or entry will be cancelled. NO EXCEPTIONS!** Requirements are:**
  - **Market Hogs:**
    - Photo #1: Market hog with exhibitor: side view of animal with exhibitor. Photo must show entire animal, as close & clear as possible to identify animal & exhibitor.
    - Photo #2: Exhibitor with hog showing ear notches, or none if ears not notched.
    - Breeder information must be provided upon request. Bill of Sale required for Independents.
    - All Proof of Ownership documents must be submitted & accepted for back-up/replacement animals.
  - **Market Lambs & Goats:**
    - Photo #1: Market lamb or goat with exhibitor: side view of animal with exhibitor. Photo must show entire animal, as close & clear as possible to identify animal & exhibitor.
    - Photo #2: Exhibitor with lamb/goat showing scrapie tag (both sides if both sides are printed)
    - Bill of Sale showing scrapie identification number, name of breeder & date of sale.
    - All Proof of Ownership documents must be submitted & accepted for back-up/replacement animals.
- **Label photo(s) with exhibitor's name, club & identifying info. (eartag, primary, backup, etc.). Photo(s) must be color, 4"x6" or larger & high enough resolution for identification. **Send all proof of ownership documentation in one email.****

- The Fair reserves the right to refuse photos not meeting requirements. It is the exhibitor's responsibility to provide photo(s) meeting Fair requirements by deadline date or entry will be cancelled. Additional photos may be requested and must be submitted by the deadline date.
- **If you are on a waitlist, you must submit all proof of ownership documents by deadline to remain on waitlist.**
- **SUBMISSION OPTIONS & DEADLINES:**
  - EMAIL: Electronic photos will be accepted until 5 pm March 26, 2021 (Friday before deadline). Confirmation will be sent that photo was received & accepted or acceptable photo will be requested. If emailed photos submitted on March 26 are not accepted, a hard copy must be submitted no later than 5:00 p.m. March 29, 2021 **or entry will be cancelled.** If you do not receive confirmation that photo was accepted, contact the Fair Office before the deadline.
  - Electronically submitted photos MUST contain the exhibitor name & club/chapter in "subject" line or it will be refused and returned. **PLEASE SEND ALL DOCUMENTS IN ONE EMAIL to: [livestock@silverdollarfair.org](mailto:livestock@silverdollarfair.org)**
  - PHOTO HARD COPIES must be received no later than 5:00 pm March 29, 2021.
- **AUCTION COMMISSION: 6% of total auction amount for all market animals.**
- **2021 SILVER DOLLAR FAIR EXHIBITOR HANDBOOK** is scheduled to be online Feb. 1, 2021 at [silverdollarfair.org](http://silverdollarfair.org). It is your responsibility to view, read & understand information provided in the Exhibitor Handbook, including class information entry deadlines, exhibit receiving/release dates and State & Local Rules.
- **DRUG USE FORM:** Market animal exhibitors will be required to submit a drug use form for their entry to be eligible for the Auction. Form is available on the website. See Local Rules for complete information.
- **ANIMAL ENTRIES FROM OTHER STATES:** Please see CDFA State Rules: [www.cdfa.ca/gov/fe](http://www.cdfa.ca/gov/fe) "Section X. Animal Health Rules" for each specie's specific out of state entry information.
- **MARKET GOATS & LAMBS** will be health checked at the scale prior to weigh-in to determine eligibility. Health check will include, but not limited to: lamb tail dock, lamb fungus, lamb's teeth, goat milk teeth & slick shearing compliance. State & Local Rules will be enforced. **Any animal exhibiting contagious disease will be released.**
- **WEIGHT REQUIREMENTS:**
  - **Market Hog weight limits: 210 - 280 lbs.** Maximum weight 290 lbs. Any hog weighing less than 210 lbs. or more than 290 lbs. will be sifted for weight at the scale. "Pay to" weight for hogs at the Junior Livestock Auction is 280 lbs. Only animals judged "market acceptable" are eligible for auction. Judges have the authority to sift animals not meeting State Judging Standards.
  - **Market Goat weight limits: 60 - 105 lbs.** Maximum weight 115 lbs. Any goat weighing less than 60 lbs. or more than 115 lbs. will be sifted for weight at the scale. "Pay to" weight for goats at the Junior Livestock Auction is 105 lbs. Only animals judged "market acceptable" are eligible for auction. Judges have the authority to sift animals not meeting State Judging Standards.
  - **Market Lamb weight limits: 110 – 150 lbs.** Maximum weight 160 lbs. Any lamb weighing less than **110 lbs.** or more than 160 lbs. will be sifted for weight at the scale. "Pay to" weight for lambs at the Junior Livestock Auction is 150 lbs. Only animals judged "market acceptable" are eligible for auction. Judges have the authority to sift animals not meeting State Judging Standards.
- **REPLACEMENT (back-up) ANIMALS** of the same specie as exhibitor's primary entry, will be allowed as approved by Fair Management only if ownership information is submitted prior to entry closing (photos, breeder information, bills of sale, etc.), is within an immediate family & is not another exhibitor's primary animal. If an exhibitor has more than one market animal, they must declare a "primary" and a "back-up" animal prior to entry closing. Photos & identification information must be marked accordingly. No exhibitor may enter or show a backup animal that is another exhibitor's primary animal entry. **Under no circumstances, can a backup animal be shared outside an immediate family or with a group of exhibitors. \$15.00 non-refundable entry fee must be paid for each back-up animal entered.** Backup animals are not eligible to be entered in any other Division. See Local Rule #72.
- **INDEPENDENT EXHIBITOR ENTRY INFORMATION** is available on website. It is your responsibility to obtain information and meet all requirements.
- **BREEDING LIVESTOCK & STILL EXHIBIT ENTRIES CLOSE APRIL 15, 2021.** Use separate entry form for breeding entries & still entries by department please. **Breeding Livestock Entry Fee - \$10.00 per class.**
- **QUALITY ASSURANCE CERTIFICATION REQUIREMENT DUE NO LATER THAN 5:00 pm APRIL 15:** All Junior Livestock Exhibitors are required to participate in a certified Quality Assurance & Ethics Awareness Training or complete YQCA (Youth for Quality Care of Animals) & provide current certificate of completion by 5 pm April 15. If certificate it is not current or valid the entry will be disqualified. YQCA is a national multi-specie assurance program for youth. See YQCA for information/ certification.
