2021 Silver Dollar Fair Rabbit Meat Pen Exhibitor Requirements

- **SUBMIT ENTRY & \$15 ENTRY FEE PER PEN BEGINNING 8:00 a.m. FEBRUARY 1, 2021 through 5:00 p.m. April 27, 2021 as per Entry Lottery information below. \$15.00 processing fee for each backup animal entered and all entry fees are non-refundable. Entries close 5 pm April 27(30-day ownership deadline)**
- **2021 Local Rules are available at www.silverdollarfair.org. IT IS YOUR RESPONSIBILITY TO READ & UNDERSTAND LOCAL RULES PRIOR TO ENTERING A MARKET ANIMAL. Please initial where specified on entry form that you agree to read & understand State & Local Rules.**

- **Individuals may submit one market animal entry form. Exception may be made if exhibitor is on a waitlist.**
- **Online entries must submit the Livestock Liability Release by email to livestock@silverdollarfair.org or mail hard copy to above address for entry to be valid.**
- **Upon signing the entry form the Exhibitor/seller agrees with the requirement for all market animal graded "market acceptable" will be sold at the Junior Livestock Auction destined for harvest. There will be no live animal pick up of Auction animals. NO EXCEPTIONS.**
- **INDEPENDENT EXHIBITOR ENTRY INFORMATION is available on the website or you may contact the Fair Office. It is your responsibility to obtain information and meet all requirements.**

► 2021 ENTRY LOTTERY RULE ◀

- **Market animal entries will be limited to 45 steers, 270 hogs, 210 lambs & goats combined, and 40 rabbit meat pens.**
- Entries will be received by the Fair Office between the entry opening date specified in the local rules and close of entries, which is the ownership deadline as specified in State Rules.
- If at 12:00 noon on the 5th business day after entry opening, there are more market animal entries than the limit allows (for a specie), the Fair shall institute a public lottery to select the specified number of entries allowed from all entries for each specie, received from the beginning of entry opening.
- This public lottery will take place at 4:00 p.m. on the 5th business day after entry opening in the Fair Administration Office and shall be open to any interested party to witness.
- Entries not selected in the lottery for participation in the market animal show will be entered into a secondary lottery to rank a waitlist order.
- Any entry submitted after 12:00 noon on the 5th business day after entry opening will be accepted if entry limits for that specie have not been exceeded. If entry limit has been reached entries will be placed on the waitlist in order of receipt by the Fair Office, behind entries that were received in the Fair Office prior to 12:00 noon on the 5th business day after entry opening.
- If an entry that was selected to participate in the market animal show withdraws for any reason, entries from that specie waitlist will be selected to participate in the Market Animal show based on rank order.
- Entry fees are due when entry form is submitted.
- If an exhibitor is not selected to participate in the market animal show as a result of the lottery process, the entry fee will be refunded upon request.

- **SUBMIT PROOF OF OWNERSHIP NO LATER THAN 5 p.m. APRIL 27, 2021 (30 days prior to the opening day of the Fair as required by State Rules).**
PHOTO(S) OF EXHIBITOR WITH MEAT PEN, BREEDER NAME & PERMANENT EAR TATTOOS NO LATER THAN 5 pm APRIL 27, 2021 must be submitted and approved, or entry will be cancelled (30 day ownership deadline). If photos, tattoos & required proof of ownership is not received by that time, entry will be cancelled. NO EXCEPTIONS.

➤ **PHOTO REQUIREMENTS:**

Photo #1 must show pen of rabbits with exhibitor, as close as possible to identify animals & exhibitor. Label photo(s) with exhibitor's name, club & tattoos (may be multiple photos). Photo must be color, 4"x6" or larger & high enough resolution for identification. Exhibitor may submit one photo with pen of 3 rabbits with exhibitor or photos of exhibitor with each rabbit individually, as long as each is labeled with name and tattoo number of that animal. If exhibitor has more than 3 rabbits (back-up animal), photo must be submitted with that animal as well.

- Photo #2 must show exhibitor & animals showing rabbit's ear tattoos (may be multiple photos)
- The Fair reserves right to refuse photos not meeting requirements. It is the exhibitor's responsibility to select & provide photo(s) meeting Fair requirements by deadline date or entry will be cancelled.

➤ **SUBMISSION OPTIONS & DEADLINES:**

- **EMAIL:** Electronic photos will be accepted until 5 pm April 26, 2021 (day before deadline). Confirmation will be sent that photo was received & accepted or new, acceptable photo will be requested. If emailed photos submitted on April 26 are not accepted, a hard copy must be submitted no later than 5:00 p.m. April 27, 2021 or entry will be cancelled. If you do not receive confirmation that photo was accepted, contact the Fair Office before the deadline. Please send all documents in one email. **Electronically submitted photos MUST contain exhibitor name & club/chapter in the "subject" line or photo may be rejected, returned and refused.**

- **PHOTO HARD COPIES MAY BE SUBMITTED TO FAIR OFFICE** and must be received no later than 5:00 pm April 27, 2021. Photos must have youth's name & club/chapter on back, along with breeder information.

- **Rabbits, three of the same approximate age and same breed and variety, and not over 10 weeks of age will comprise ONE Meat Pen for the Junior Livestock Auction.**
- **Weight for each rabbit in pen must be a minimum of 3½ lbs., and not more than 5½ lbs.**
- **6% Auction Commission for all market animals.**
- **Only 3 Rabbit Meat Pen animals will be allowed at the Fair. Make your decision on which 3 are to be weighed in at home. No back-up animals will be allowed to check in.**

IF YOU ARE ON THE WAITLIST, YOU MUST SUBMIT PHOTOS, TATTOOS & REQUIRED PROOF OF OWNERSHIP INFORMATION TO REMAIN ON THE WAITLIST

REPLACEMENT (back-up) ANIMALS of the same species as exhibitor's primary entry will be allowed by Fair Management only if ownership information is submitted prior to entry closing (photos, breeder information, bills of sale, etc.). \$15.00 Entry/Processing fee must be paid for each backup pen entered & is non-refundable. See Local Rule #72. Backup rabbits must be entered hard copy. Please call the office or email for more information on # of rabbits per fee.

DRUG USE FORM: Market animal exhibitors are required to submit a drug use form to be eligible for the Auction. Form is available on our website or you may contact the Fair Office. See 2021 Local Rules for complete information.

QUALITY ASSURANCE CERTIFICATION REQUIREMENT DUE NO LATER THAN 5:00 pm APRIL 15: All Junior Livestock Exhibitors are required to participate in a certified QUALITY ASSURANCE & ETHICS AWARENESS TRAINING or complete YQCA (Youth for Quality Care of Animals) and provide current certificate of completion no later than 5:00 pm April 15, 2021 or entry will be disqualified. Certification will be verified and if it is not current or valid the entry will be disqualified. YQCA is a national multi-specie assurance program for youth. See YQCA.org for information/certification.

2021 LIVESTOCK EXHIBITOR HANDBOOK will soon be available at www.silverdollarfair.org. It is your responsibility to view, read & understand the Exhibitor Handbook, including class information, entry deadlines, exhibit receiving/release dates and State & Local Rules. Please initial where specified on entry form that you agree to read & understand rules.

BREEDING LIVESTOCK & STILL EXHIBIT ENTRIES CLOSE APRIL 15, 2021. All Breeding entries must be submitted hard copy by mail to the Fair Office.
