SUBJECT: 2021 SILVER DOLLAR FAIR MARKET ENTRY INFORMATION

2021 LOCAL RULES are available at www.silverdollarfair.org. It is your responsibility to read Local Rules before submitting a market animal entry. Please feel free to email questions to livestock@silverdollarfair.org

- ▶ **RABBIT MEAT PEN ENTRIES OPEN** at 8:00 a.m. Monday, Feb. 1st. New this year, entries will be accepted online via the link on our website, mailed in or dropped through the office mail slot during business hours. Please note if you are completing your entry online, a copy of the Exhibitor Release of Liability waiver must be mailed in or scanned via email to livestock@silverdollarfair.org If at 12:00 noon on the 5th business day after entry opening there are more than 40 meat pens (limit) the Fair will institute a lottery to draw for the 40 spots. After the first 40 have been drawn, we will draw waitlist order. See website for complete lottery rule.
- ▶ **Market Steer entries closed Jan 27, 2021** (120 day ownership deadline).
- ▶ **MARKET GOAT, HOG & LAMB entries** are open at this time. Entries will close 5:00 p.m. March 29th. There are currently not wait lists for market hogs, goats or lambs. Entries may be submitted online through the link on our website or dropped through the office mail slot during business hours. *Backup animals may not be entered online*
- ▶ **MARKET ANIMAL PROOF OF OWNERSHIP- All proof of ownership requirements for market goat, hog or lamb are due by 5 p.m. Monday, March 29th. If not submitted by 5 p.m. March 29 entries will be disqualified. Emailed items must be received by 12:00 noon, Fri. March 26, 2021. Email confirmation will be sent that submissions were accepted. If you do not receive confirmation, contact the Fair Office prior to deadline.**

Requirements Due March 29 (read carefully):

- **Sheep & Goats- Primary and Backup animals**
 - Photo #1: Market lamb or goat with exhibitor: side view of animal with exhibitor. Photo must show entire animal, as close & clear as possible to identify animal & exhibitor.
 - Photo #2: Exhibitor with lamb/goat showing scrapie tag (both sides if both sides are printed)
 - Bill of Sale showing scrapie identification number, name of breeder & date of sale.
 - **Hogs- Primary and Backup animals**
 - Photo #1: Market hog with exhibitor: side view of animal with exhibitor. Photo must show entire animal, as close & clear as possible to identify animal & exhibitor.
 - Photo #2: Exhibitor with hog showing ear notches, or none if ears not notched.
 - Breeder information
 - **Bill of Sale required for Independent exhibitors.**
- ▶ If you purchase a market animal outside of the State of California, be aware of State Rules regarding health inspections & entry permits. See State Rules (www.cdfa.ca.gov/fe) or call the Fair Office if you have questions.
 - ▶ **YQCA Certification Requirement:** All Jr. Livestock Exhibitors are required to participate in a Quality Assurance & Ethics Awareness Training. The YQCA (Youth for Quality Care of Animals) course is available online at yqca.org. Current certificate of completion is due no later than 5 pm, April 15, 2021 or your entry will be disqualified.
 - ▶ **2021 EXHIBITOR HANDBOOK will be available on our website February 2021.** No hard copy will be mailed.
