FEES:

If you are issued a contract, the minimum guarantee of \$500.00 and a \$50.00 utility fee will be required when you return your signed contract by the date stipulated. Any space not paid for by June 1st will be considered cancelled and the space resold. All other requirements (insurance, seller's permit, etc.) must be on file prior to the fair opening. Please review our Vendor Handbook and Rules & Regulations that can be located on our website.

BOOTH SPACE PLACEMENT:

Placement depends on availability and benefit to the operation of the fair. The Siskiyou Golden Fair staff will try to meet your accommodation requests as best as possible if you are granted a contract.

INSURANCE:

The State of California requires proof of commercial general liability insurance with a minimum coverage of \$1,000,000.00 per occurrence. If you do not have your own insurance, contact the fair office for the current premium cost per concession available through the fair from California Fair Services Authority. If a contract is deemed hazardous, insurance coverage ranges from \$1,000,000.00 to \$3,000,000.00 depending on the activity. A premium quote is available from CFSA.

CALIFORNIA SELLER'S PERMIT:

The California Department of Tax and Fee Administration requires a current sellers permit if you are selling products. There are regular and temporary permits depending on the amount of your sales and you cannot legally sell taxable items in California until you have been issued a seller's permit. For further information of a permit application please contact 800-400-7115 or www.boe.ca.gov.

HEALTH REQUIREMENTS:

Food concessionaires must have a current California Food Handlers Certification (also known as "ServSafe"). Food concessionaires must also comply with all requirements of the Siskiyou County Environmental Division/Health Department (contact 530-841-2115 for further information). A copy of your current permit must be on file prior to the opening of fair.
