Camping Rules and Regulations

General Information

- Camping Application can be found on the fair webpage and will need to be filled out correctly with proper signatures and mailed to the address listed on the form.
- \$40.00 per family fee must accompany the camping application.
- Please make your check payable to the St. Charles County Fair, Inc.
- Only one campsite per family.
- Camp ground opens Friday 5 PM - 8 PM, before setup day for Superintendents ONLY.
- Camp ground opens at 11:00 AM Saturday for exhibitors.
- Campground will be patrolled by Saint Charles County Sheriff and Fair Security.
- Check out is 10:00 AM Sunday morning, no campers will be able to leave till this time.

Rules and Regulations

- Camping permits must be visible at all times.
- Main Campground gates will be open till 4:00 PM Tuesday through Friday, closed all day Saturday until Check Out.
- No Vehicles (cars, trucks, golf cars, atvs) allowed in the camp ground unless permitted.
- Quiet hours will be observed from 1 a.m. to 7 a.m. All radios, stereos, and all other audio equipment must be turned down during this time. No loud music is permitted to be played or broadcast at any time during quiet hours; all minors must be at their own site at quiet hours.
- No campfires.
- Fire lane must be maintained open at all times.
- No person under the age of 21 shall possess or consume alcoholic beverages within the campground. Anyone who possesses or consumes alcoholic beverages must provide identification and proof of age upon request.
- Responsible adult(s) will be held liable for any vandalism by minor children and will be required to pay for any damages.
- Firearms, paint guns, fireworks, explosives and weapons are prohibited and will result in the loss of camping privileges.
- All persons shall comply with all lawful instructions of the campgrounds staff or any police/security officer.
- Only one 30 amp electrical outlet per camp-site allowed.

- Please leave your campsite as clean as you found it. Place trash into trash containers.
- No dumping allowed on the grounds.
- Camping allowed and is open to the Fair Board Members, Fair Superintendents, Fair Board Support Staff, and 4-H / FFA Exhibitors.
- Management reserves the right to make necessary changes in the rules and regulations to be in the best interest of the campground and to be in compliance with federal, state and local laws. Anyone refusing to abide by the rules and regulations or creating a disturbance will be asked to leave without refund. We reserve the right to refuse service to anyone.

*Absolutely no coolers with alcoholic beverages will be allowed within the inner gates of the fairgrounds.

***In the event of circuit overloads, Fair management reserves the right to limit electrical service during exceptionally high-demand periods.
