

Tillamook County Fair Pavilion Riding Permit Rates and Rules

Riding permits are required by any person riding a horse on the Tillamook County Fairgrounds. Permits are issued per person, not per horse.

Riding permits bought mid-month or mid-season are not pro-rated.

There are no refunds on riding permits.

Season is September through June each year.

One riding permit is provided to each stall renter at no additional charge.

Availability:

Riding is permitted in the Pavilion and outdoor arena only. Riding hours are between 8 a.m. and 8 p.m., Sunday through Saturday. No open riding is permitted when an event or activity is scheduled in the above areas. Monopolizing of the facilities during open riding is not allowed by any individual or group.

A calendar is printed each month with the month's events listed. It will show what days have open riding and what days will be closed but is subject to change without notice. This will allow permit holders to plan around scheduled activities. The Fair reserves the right to book events at any time. We make every effort possible to post any changes in the monthly schedule. Announcements are posted in the Fair Office and on the electronic reader board outside the fairgrounds. Calendars are posted in the Pavilion and are available in the Fair Office. Please call with any questions about the availability of the Pavilion. The Fair Office is open Monday – Friday, 8:00 a.m. to 5:00 p.m.

Rules: These are general rules and are subject to change without notice. Any matter not expressly provided for shall rest solely within the discretion of the Tillamook County Fair Board or Manager.

1. Individuals using the Pavilion will enter through gate number 1, South of the building.
2. Speed limit on the Fairgrounds is **5 mph**. This must be strictly followed for the safety of all patrons and animals on the grounds.
3. Dogs are **NOT** allowed on the Fairgrounds at any time. Exceptions are given only for service dogs and dogs on exhibit.
4. No loose or unattended horses allowed. Horses may be tied to tie rails only. Trees, panels, pens, signs, garbage cans, etc. are not acceptable places to tie horses.
5. Parking allowed in designated area West of the Pavilion only. Cleanouts are NOT allowed in the parking area.
6. It is your responsibility to clean up your area before leaving the fairgrounds. Please sweep up any excess hay and dispose of all manure.
7. Cleaning of horse trailers must be in designated areas only, and all manure must be disposed of at manure slab. Any person cleaning horse trailers, or leaving debris, on roadways will have riding permit revoked.

8. Riding permitted in the Pavilion and open South Arena only. Riders and horses who do not currently rent stalls on the fairground are NOT allowed in the stable area Southeast of the Pavilion. Riders and horses are not allowed past the Pavilion to the Northeast.
9. Riding permit must be displayed at all times while on the grounds. If you are found letting others in to ride for free, your own pass will be revoked.
10. It is your responsibility to make sure that your horse has the necessary vaccinations. This is a public facility with many horses on the grounds each day.
11. There are no refunds for lost permits.
12. **Anyone under 18 years of age MUST wear a helmet while riding/handling a horse while on Tillamook County Fairgrounds Property.**

This is an EQUINE FACILITY. All activities on these grounds are subject to the Equine Inherent Risk Law (ORS 30.687-30.697). By your presence on these grounds you have indicated that you have accepted the limits of liability resulting from inherent risks of equine activities.

UNDER OREGON LAW, NO PERSON SHALL BE LIABLE FOR DAMAGES SUSTAINED BY ANOTHER AS A RESULT OF RISKS INHERENT IN EQUINE ACTIVITY, IN SO FAR AS THOSE RISKS ARE, OR SHOULD BE, REASONABLY OBVIOUS, EXPECTED OR NECESSARY TO THE PERSON INJURED. ORS 30.689
