Mission Statement

The Exposition will provide a wholesome, educational, cultural and recreational experience for area citizens by hosting the Tri-State Fair and Rodeo and other events to strengthen the Amarillo economy.

The Exposition

- ◆ Chartered as a 501 (c)(3) non-profit organization in 1923.
- ◆ Year-round facility use on 104 acres of maintained property.
- ◆ Over \$42 million-economic impact to the Amarillo area since the opening of the Amarillo National Center. (Impact study completed, June 2008)
- ◆ 34 college/university scholarships awarded to area students (one 4-H, one FFA, one At-Large) since 2005.
- ◆ Grounds in use an average of 240 days per year.
- ◆ 300,000+ visitors, vendors, exhibitors and participants per year.

The Tri-State Fair & Rodeo ~

Nine day fair and rodeo-largest event in the Texas Panhandle.

Returns approximately \$500,000 in premiums, awards and tickets to regional youth.

Over 600 volunteers donate approximately 14,000 hours of service each year. Several with over 50 years of service.

Educational programs provided to 5,000 students each year.

Named one of the "Top 5" Medium Size Rodeos by the Professional Rodeo Cowboy Association.
