Canned Goods

1. Judging will be based on the most current Ball Blue Book specifications and will be judged by appearance, recipe and proper canning procedure.
2. Must submit recipe for each entry; bring on entry take-in day. Do not mail. **Recipe must include processing procedure used, time processed and date it was canned.**
3. All Canned Goods must be in clear canning jars with lid and ring; no colored jars will be accepted. Jams, jellies and preserves must be in standard ½ pint jars and others must be in standard pint or quart jars. Must follow proper canning process for size of jar used.
4. No labels or decorations on jars or lids
5. Honey should be clear and free from foreign particles. Chuck honey should be perfectly capped, free from stains, bee bread and fingerprints. Edges should be clean cut, not ragged. One piece only in each jar as wide as the mouth will permit and long enough to extend from the bottom to the top without jamming. Jar cover should be perfect and screwed on tight, thus preventing leakage.
6. Honey must be in Queen Line or 1 lb. honey jars.
7. Pollen must be in standard clear ½ pint jars.

Baked Goods

1. Baked goods must be in a disposable container and covered or they will not be accepted. CONTAINERS WILL NOT BE RETURNED



2. All baked goods must be cooked fully; no items with raw eggs will be accepted. Items will not be refrigerated prior to judging.
3. Must submit original recipe for each entry; bring on entry take-in day. Do not mail.
4. Recipes must be original and become property of the Tulsa State Fair.
5. Use of prepared mixes, pie crusts or prepared materials (i.e. icing) is prohibited.
6. **NEW!** Cakes, with the exception of Angel Food, must be baked in 8" or 9" round, square, Bundt pans – whichever is best suited for cake. Take out of cake pan and place on cake board.
7. Yeast bread must be submitted in full size loaf, no mini loafs will be accepted.
8. Rolls, biscuits, muffins and cupcakes must have six (6) in a disposable airtight container.
9. All pies must be baked in 9" disposable aluminum pie pan and shown in same.
10. **NEW!** Cookies, brownies and candies must have six (6) in a disposable airtight container and can be placed on a paper plate in a resealable gallon baggie.
11. All baked goods will be judged directly after take-in.
12. Exceptional Classes refer to those with limited mental capacity or physical disability.

Homebrewing

1. Entrants must be 21 years of age or older to enter competition.
2. Only one entry per class is permitted. May enter as many classes as you would like but may not enter multiple sub-classes.
3. Two bottles must be submitted for judging and displaying.
4. Do not put labels on bottles; tags will be supplied by the Tulsa State Fair.
5. Beer/Ciders must be amateur – homemade process.
6. One bottle will be kept chilled until judging.
7. Judging criteria will be based upon Bottle Inspection, Aroma, Appearance, Flavor, Mouth Feel and Overall Impression.
8. All judging will be held in closed sessions with BJCP certified judges present. All judging will be blind.
9. Judges are not allowed to judge their own homebrew.
10. Homebrews will be displayed throughout the duration of the Fair.
11. Please note: some classes may be combined, at the Superintendent's discretion, for the purpose of awarding prizes.
12. Judging sheets and ribbons will be mailed after the Fair. You will not need to return for take-out.
