- ✓ Save this completed document to your computer.

- ✓ Follow the steps below to upload this document with your online entry:

1. After you checkout your online entry cart, you will be directed to upload files. Compare the WEN# on the online receipt to the WEN# on the upload website to make sure you are uploading the correct files for each exhibitor.
2. In the first box click "choose file" click on your saved document then click "open" and "upload" to upload the county verification form.
3. **Click "Done" and then "Done" to confirm.** We will not receive the files unless you complete this final step.
