



## GENERAL RULES & REGULATIONS

Please read all general rules and division rules carefully. All exhibitors are responsible for compliance with all rules.

1. **COMPLIANCE WITH RULES:** Exhibitors must comply with all rules and regulations of the Tulsa State Fair and work must be completed by the exhibitor only.
2. **SUBMISSION OF ENTRIES:** All entries must be entered and paid for online.
3. **ENTRY FEES:** All entry fees are due at the time of entry. Payments will only be accepted online.
4. **REFUNDS:** No refunds of entries will be mad. Only one entry permitted per class.
5. **TAKE IN OF ENTRIES:**  
**September 14:** Antiques, Canned Goods, Fine Arts, Hand Arts, Honey, Homebrew, Horticulture, Photography, Senior Citizens  
**September 21:** Baked Goods, Horticulture  
Do not leave sacks, supplies or other material used to transport your exhibit.
6. **ENTIRES MARKED PROPERLY:** All entries must have name, division and class marked on the back or bottom of each entry.
7. **CLASSIFCATION OF ENTRIES:** Superintendents have been instructed to reclassify an entry if it does not fit the classification entered by the exhibitor.
8. **JUDGING OF EXHIBITS:** All judging in the Competitive Exhibits Adult & Junior Divisions will be completed before the fair opens. A judge has the right to not award a first place ribbon if they feel none of the entries merit the award. Placing and results will not be given out over the phone prior to the fair or opening or during the fair.
9. **INTERFERENCE:** No exhibitor will be allowed to interfere in any way with the Superintendent or Judge in the performance of their duties. A violation of this rule will be excluded from the exhibition.
10. **DISPLAY OF EXHIBITS:** Management reserves the right to exclude from the exhibit any article it deems unworthy or inappropriate. After judging, the Tulsa State Fair reserves the privilege of displaying articles, or in the case there is not adequate space, they reserve the right of setting the articles back for the exhibitor to pick up at the conclusion of the fair.



11. **SWEEPSTAKES:** Sweepstakes awards will only be awarded in divisions where five (5) or more entries are being judged. Sweepstakes awards are left to judge's discretion. 1st, 2nd and 3rd place winning entries may not be entered in future years after winning any Competitive Exhibits or Contest award. If an item is entered that has previously won is entered into the competition, Fair Management has the right to disqualify the entry.
12. **RELEASE OF ITEMS:** The Tulsa State Fair will not take responsibility for the mailing of items; items must be brought and picked up in person during the designated dates and times. Person dropping off/ picking up items does not have to be the exhibitor.
