

## WCFA Youth Division Baked and Canned Goods Rules

The Youth Baked and Canned Goods Division of the Walker County Fair will be open to Walker County students who are enrolled FCCLA Chapter members, school sponsored culinary arts students or 4-H Club members who are active participants of a 4-H Food and Nutrition Club, beginning September prior to the County Fair. Exhibitors in the youth section must be in grades 3-12 or be 9-18 years of age.

Each 4-H exhibitor must have participated in at least two documented content area activities, i.e. Food and Nutrition Club meetings. FCCLA exhibitors must meet FCCLA meeting requirements as required by the FCCLA Advisor. School sponsored culinary arts students must meet the requirements of their programs.

An entry fee of \$5 will be charged for each product. Only ONE product may be entered in each class. Check in will occur during the designated times, date and location as printed in the Walker County Fair Association Schedule.

All entries must be the work of the exhibitor.

### **The Baked Goods Division will be composed of seven major classes:**

1. Cakes – Both the cake and the icing must be made from scratch. Cupcakes and cake balls made from scratch will be accepted; however, all must be of same recipe and decoration. One slice must be cut before entry and left in place.
2. Cookies - All cookies and icings must be made from scratch. Brownies made from scratch are included in this section.
3. Candies - any type of candies made from scratch.
4. Decorated Cakes – Cakes may be made from a mix but the icing, fondant or any other type of covering must be made from scratch. All parts of the cake must be edible with the exception of the items used for support. Any cake displaying purchased or non-edible decorations will be disqualified. Decorated cakes are not considered for “Best of Show”, however; the cake must be fresh and consumable at time of judging. The cakes will be judged on appearance but the judges reserve the right to taste the cakes at their discretion.
5. Miscellaneous – Miscellaneous includes quick breads, cakes, candies, cookies, pies and pastries and yeast breads with additions such as mixes (jello, pudding, etc.), or any item that doesn't clearly fit in other classes. Any product made with graham crackers, cookies, premade products, etc. will be entered in this category. Cupcakes and cake balls will be accepted; however, all must be of same recipe and decoration. One slice must be cut before entry and left in place.
6. Pies and Pastry – Pastry crust and filling must be made from scratch. One slice must be cut before entry and left in place. (Chiffon, cream pies or pies with meringue will not be accepted.)

7. Yeast Breads - No bread machine products are eligible. Entire product must be made from scratch with yeast used as leavening agent. One slice must be cut before entry and left in place.

An entry is defined as “a whole product” or in the case of individual items such as brownies, cookies, candies or rolls there must be at least twelve pieces included in the entry. All entries should be on sturdy disposable containers and covered. The container will not be returned to the exhibitor.

No refrigeration will be provided; therefore, entries requiring refrigeration will be disqualified. No ice chests or coolers will be allowed.

Baked Good Items will be available for sale in the Sweet Shop. Sweet Shop hours will be provided at upon entry.

### **The Canned Goods Division will be composed of nine major classes:**

All canned goods must be made from scratch unless the product is entered in the Miscellaneous class. No mixes can be used in any class other than Miscellaneous. The Miscellaneous class can include canned goods made with ingredients such as jello, purchased juices, etc.

Any type of food that has been “Pressure Canned” or “Water Bathed” in standard commercial type canning jars such as Ball, Kerr or Mason Jars are eligible. Mayonnaise jars or the like will be disqualified. Any item that is not properly sealed will be disqualified. If the seal is broken, the entry will be disqualified.

Canned goods must have a label identifying the product name on the jar. If the product is not labeled, it will be disqualified.

### **General Rules**

The recipe must be submitted when the food product is entered. The recipe should not be attached to the product and should not have exhibitor’s name on it. The recipe should not have any person’s name in the title.

Baked and Canned Goods must be turned in the first Friday of the Fair, from 7:00 – 9:00 a.m., in the Main Building. Judging will be held on the same day and results will be posted by 5:00 p.m. that day. The judging is not open to the public.

First through 15<sup>th</sup> place and participant ribbons will be given to all entries according to the

judges' decision.

The judges will designate a "Best of Show Baked Goods" and a "Best of Show Canned Goods" There will be a presentation ceremony, prior to the Baked and Canned Goods Auction on the last Saturday of the fair to present "Best of Show" Awards.

The Baked and Canned Goods auction will be held the last Saturday of the Fair. The following items will be sold in the auction, according to the judges' placings:

### Best of Show Baked Goods

Cakes – Places 1, 2, 3

Cookies – Places 1, 2, 3

Candies – Places 1, 2, 3

Decorated Cakes – Places 1, 2, 3

Miscellaneous – Places 1, 2, 3

Pies – Places 1, 2, 3

Yeast Breads – Places 1, 2, 3

### Best of Show Canned Goods

Fruits – 1<sup>st</sup> place

Jams – 1<sup>st</sup> place

Jellies – 1<sup>st</sup> place

Juices – 1<sup>st</sup> place

Miscellaneous – 1<sup>st</sup> place

Pickles – 1<sup>st</sup> place

Relish – 1<sup>st</sup> place

Salsa – 1<sup>st</sup> place

Vegetables – 1<sup>st</sup> place

Exhibitors selling their entries are required to bring a fresh product (whole pie, cake, etc. or sealed canned goods) to the Baked and Canned Goods Auction. Exhibitors who placed and are selling under the Decorated Cake division have the option of bringing another decorated cake or a substitute product to give the buyer. The products will be delivered to the buyer as soon as they are sold.

Exhibitors selling in the Auction will be required to check in at the designated time (noted at time of turning in food products). If the exhibitor is not checked in at the designated time, they will not be allowed to sell their product in the Auction. Once the sale order has been determined, there will be no alterations to the order. If an exhibitor is unable to participate in the auction due to illness or other approved absence a substitution will be allowed with a written note.

All baked and canned good items become property of the WCFA upon entry into the contest. No entries will be returned.

Exhibitors in the Baked and Canned Goods Division will adhere to any and all other Fair rules pertaining to work hours, parent work hours and attending final day mandatory clean-up.

Any exhibitor who has won "Best of Show" in either division is not eligible to enter the same class the next year. All Judges' decisions and announced results will be final.
