# WALLA WALLA *Fairgrounds*

1. Camping stay is for arrival date to departure date only.
2. Payment and forms must be received prior to any stay.
3. Payments must be current for any stays.
4. The Fairgrounds is zero tolerance crime.
5. Must follow WW County noise ordinance.
6. Be courteous, be respectful, be kind. There may be other campers as well as the neighbors around the grounds.
7. No excessively loud radios and/or TVs.
8. No alcoholic beverages allowed outside of RV. Follow State laws and regulations.
9. No marijuana use allowed on grounds. Follow State laws and regulations.
10. Follow State Laws and Regulations pertaining to firearms.
11. I agree to leave and remove my camping equipment/trailer no later than the departure date. I understand that my camping equipment/trailer may be moved into storage after the departure date.

Failure to abide by the above listed rules will result in immediate removal from the Fairgrounds.
