2. Before making application for entry, read rules governing same carefully. **DOUBLE ENTRIES (LIVESTOCK ONLY) MUST BE LISTED SEPARATELY.** Please list in the order they appear in Premium Book.
3. **If you are a Junior Exhibitor showing in Open Class, you must pay the Open Class Entry Fee rather than a Junior Class Entry Fee.**
4. All fees must be submitted with entry plus \$25.00 for a Season Pass. The Pass **MUST** be issued to the individual person. No firm, farm or corporation name allowed. Make checks payable to: Walworth County Fair.
5. **NO STRAW FURNISHED BY FAIR.**
6. **NO ADDITIONS OR CHANGES ALLOWED IN ENTRIES AFTER AUGUST 3.**
7. **ENTRY TAGS MUST BE PICKED UP AT THE FAIR OFFICE.**
