Project Scope:
Build a state of the art Event facility at the Washington County Fair Complex that includes approximately 40,000 square feet of exposition space and a 14,000 sf, state-of-the-art, conference center, complete with commercial kitchen, concessions and offices.

It’s no secret that I’ve long dreamed of a comprehensive strategy to fully utilize this important piece of public land—known as the Washington County Fair Complex—to the very best of our ability. The recent groundbreaking for the long-awaited Event Center is a milestone which will change the course of how we interact with this legacy property and bring many new and exciting opportunities to our community.

The evolving story of this almost-100 acre plot of ground is intertwined with the long, rich history of our early pioneers who settled in the Tualatin Valley, raised their families, tended their farms and held the first-ever Washington County Fair, way back in October of 1854. Over the generations, forward-thinking leaders of the day purchased and developed a series of parcels of public land that would each serve as the County fairgrounds for a time.

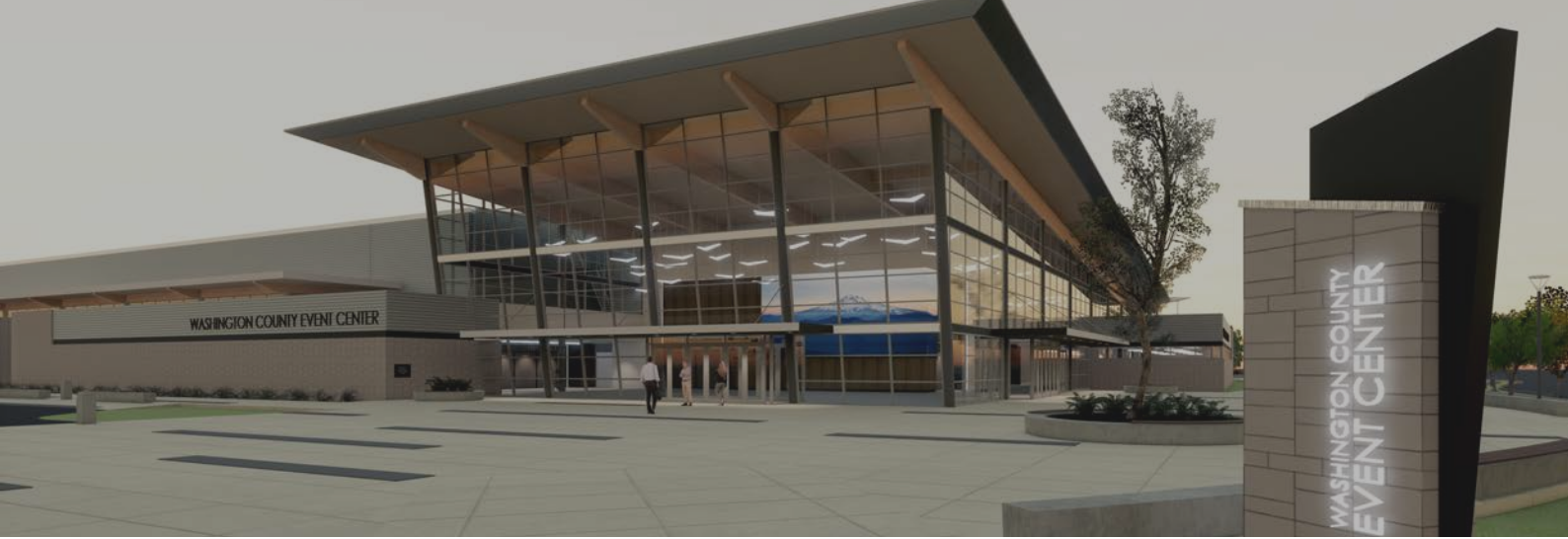
