

July 30, 1956

The Washington County Fair Board met in the office on the fair grounds at 8:30 p.m. with all members except Ball and Nyberg, present.

The minutes of the previous meeting were read and approved.

Representatives of the Washington Grange, namely Effie Dorland, Clay Dorland, Helen Brewer and Haden Brewer, were present in regard to the present building used by the grange as a restaurant. The location of the same was discussed, the condition of the building, etc., and it was agreed by the board the grange might use the same at a fee of \$25.00 to the fair. The grange representatives were to give their answer at the next board meeting.

Others present were Lennox Blatchford representing the Jersey Cattle Club and Floyd McDonald of the same club, A. W. Lindow representing the Holstein Cattle Club and Wm. Marsh representing the Guernsey Club.

Mention was made that in the premium list of Dairy Cattle there was no provision for pen fees, after which Al. Lindow suggested that 50¢ per stall be charged. This was then put in the form of a motion by Abts seconded by Sahnaw and carried that 50¢ per stall be charged in the dairy section.

It was decided that the dairy people would be given passes which would be honored on Dairy Day, and which they might mail out of the county to interested people.
