

## FAIR BOARD MEETING.

FRIDAY EVENING, JUNE 5, 1936.

The Fair Board met in the Chamber rooms June 5, at 10:00, with President Hesse presiding, and C. D. Minton and R. M. Banks present. Others present were Manager Moore, Assistant County Agent Francis and County School Superintendent Kraus.

The minutes of the last meeting were read and approved as read.

President Hesse reported that Mr. Dillon had asked for the use of one of the Fair buildings for the patriotic exercises on July 4th, if the weather was too bad to hold them outside. The President and Mr. Banks had told Mr. Dillon that they thought it would be all right.

Mr. Kraus then gave his report on the savings that could be made in his department over the premium list as of 1935. The total amount of the premiums in this department after these deductions had been made was \$137.00.

Moved by Mr. Minton, seconded by Mr. Banks, that \$2.00 be the top premium in Mr. Kraus department of the 4H club. Motion carried.

Moved to adjourn until 1:15.

Meeting called to order, with Mr. Francis and Mr. Kraus again present. Mr. Kraus again asked for an increase in his department to bring his top premiums up to equal those in the boys department. He was referred to the motion as passed at the morning session denying this request.

Mr. Francis then asked that on page 27 and 28 in the premium list under the listing "Awards" that the line "First, bus fare to State Fair" be eliminated, and that on page 28 under this heading be added "A special premium of \$40.50 will be appropriated for the purpose of providing first prize exhibitors in the livestock and crops division of the 4H club transportation to the Oregon State Fair under the direction of the Superintendent of this Division". This request was granted.

Mr. Kraus and Mr. Francis then left, and a committee came in from Pomona Grange consisting of R. Hornecker, Chas. Van Kleek and H. G. Hagg. After discussion with them regarding the premiums for the grange and farmers unions booths, it was agreed to give them a minimum of \$17.00 for each booth and a maximum of \$25.00. Discussion was held regarding a joint picnic of the Granges and Farmers Unions of the County on one day of the Fair, and asking the stores to close and take their employees to the Fair for a few hours.

This committee then left, and the rest of the day was spent going over the rest of the premium list, so that a list could be made out of the new low premiums.

The meeting then adjourned.

## RECOMMENDATIONS.

The Pomona Grange committee - R. Hornecker, Chas. Van Kleek and Oscar Hagg, - recommend that the proposal of the Fair Board to pay a minimum amount of \$17.00, and a maximum amount of \$25.00 for Grange booths at the coming Fair, be accepted, for the reason that the State appropriations for premiums, - \$1352.14, - after allowance for other departments of the Fair, which have been materially reduced, including the 4H clubs, Future Farmers and open classes, - makes it absolutely necessary to keep within this amount.
