By entering Exhibitors agree to hold harmless Washington County, the Washington County Fair, its officers, employees and agents both privately and in their official capacity from any and all damages.
- Exhibitor also agrees that by registering the exhibitor understands that violation of any WCF policies, procedures, requirements, and rules listed in this document and/ or on the Fair's website may cause disciplinary action that may result, but not limited to, in expulsion, forfeiture of premiums, awards and auction proceeds as well as future participation at the WCF.

## VETERINARY HEALTH INSPECTION INFORMATION AND RULES

- Please refer to the Animal Health Requirements on page 7 for detailed Veterinary Health Inspections information and requirements provided by the Oregon Department of Agriculture.
- Per the Oregon Department of Agriculture, all animals are required to have a Veterinary Health Inspection prior to entering the Fairgrounds and unloading animals.
- Any exhibitor who enters the Fairgrounds without having their animals go through the Veterinary Health Inspection will be immediately expelled from the Fairgrounds, will not be allowed to participate at the Fair, and forfeits any entry fee paid.
- Visit the Livestock Exhibitor section of the Fair website [www.bigfairfun.com](http://www.bigfairfun.com) to view the map showing the inspection location, exhibitor arrival location and how to enter the Fairgrounds after the inspection.

# COUNTY FAIR GENERAL RULES

1. All FFA activities at the Washington County Fair are considered a school sanctioned function. All school rules will be followed during the Washington County Fair. FFA members will conduct themselves in the same manner as they would at school.
2. Open to currently enrolled FFA members in Washington County. Must be a member per national and chapter bylaws.
3. All exhibits must be a part of the project of the FFA member exhibition
4. All entries must be pre-registered online at [www.bigfairfun.com](http://www.bigfairfun.com) according to the dates and times on the exhibitor calendar.
5. Exhibitors may enter one like exhibit in any one class.
6. Conduct of exhibitors shall be above reproach. Those guilty of misconduct may be expelled from the Fairgrounds, forfeit all prize money, may be prohibited from exhibiting in future Fairs.
7. All FFA member staying overnight at the fair are subject to the campground rules.
8. Classes will be set up or grouped by divisions per the Fair.
9. Champion Ribbons to be awarded at the discretion of the judge.
10. Non-livestock entries (AG, Mechanics, Crops, and Horticulture will be received in the Land Product area. See Exhibitor Calendar for exact dates and times.
11. All Agricultural Mechanics exhibits must have been constructed by the exhibitors during the current year. These items must be agricultural in nature. If the exhibit is large, please contact the Fair Office prior to the entry deadline to determine if space is available.
12. Any exhibitor found guilty of any illegal activity, including vandalism, while on the Fairgrounds, will be expelled from the grounds with their animal, forfeit any eligible premium(s) and entry fee(s) paid and shall not be eligible for participation at future fairs.
13. To be eligible for competition exhibits must be entered during scheduled entry times.
14. No entry or registration changes are permitted after judge sheets have been prepared, except at the judge's request. Fair Management is not responsible for finding errors in entries.
15. No animal or article will be assigned a place on the grounds until the online entry has been made.
16. No premiums will be paid on articles or animals removed before release without prior approval of Fair Management.
17. No premiums will be awarded on articles not listed in this document.
18. Exhibitors violating any rules or procedures listed in this document shall forfeit premiums and shall not be available for refund of fees paid, if any.
19. Special Awards may be offered for entries in established classifications only.
20. All offers of premiums, prizes, and awards must be picked up in person by the winner only. Identification and signature are required. No premiums, prizes or awards will be mailed.
21. **Judge's report only will be used as evidence for payment of premiums.**
22. No entry will be accepted when exhibitor prescribes conditions under which she/he will exhibit.
23. All dissemination of products, literature, signature collections, solicitation of funds, canvassing, and sales is strictly prohibited.
24. No person who attends the Washington County Fair, including exhibitors shall consume, or have in his or her possession any controlled substances or alcohol unless the alcohol is legally obtained from a duly authorized concessionaire at the fairgrounds. "Alcohol" shall include any substance described in ORS 471.005. Controlled substances shall include any substance described in ORS 475.005. No alcohol or controlled substance shall be allowed outside the fairgrounds in the camping or parking areas.
25. Dogs, except for animals allowed under the Americans with Disabilities Act and dogs in scheduled entertainment or shows such as 4-H classes, are prohibited on the Fairgrounds including the campground and parking lots. Do not leave your dog in your vehicle. Animal control will be notified.
26. At the discretion of the Washington County Fair, judging results limited to the exhibitor's name, hometown and premiums(s) awarded, may be listed on the Washington County Fair's website and Social Media accounts.
27. If premiums total to more than \$600.00, exhibitor must provide to the Fair Complex winners full social security number and address for filing a 1099 with the I.R.S.
28. Rules for Exhibitors who enter in both FFA and 4-H.
  - i) A member's project enterprise may not be the same species for both 4-H and FFA.
  - ii) In order for the projects to be split, they must be split with Market and Breeding animals in separate organizations; or if a breeding project, different breeds in separate organizations. Any violation of the exception will result in forfeiture of awards, premiums and removal from the Fair.
  - iii) When a member has started an enterprise in one organization, he/she may not switch that enterprise to the other organization during the school or 4-H club year.

# COUNTY FAIR LIVESTOCK RULES

1. ***Exhibitors are requested to carefully study information in this document, especially rules and procedures, as they will be rigidly enforced.***
2. Animals are to be shown by the owner/member.
3. Showmanship classes will be split by breed only if 4 or more exhibitors are entered in the breed.
4. Entries in sheep, beef, dairy, swine and goats may be registered, purebred, or high grades, but the judges' placing will be based on the characteristics of the breed under which the animals are exhibited. No commercial male animals can be exhibited in breeding classes.
5. Commercial Divisions – no male breeding animals will be allowed.
6. Exhibitors must show their own animal in showmanship contest with the exception of a chapter individual who has been assigned to care for an animal prior to county Fair.
7. Exhibitor must show Showmanship for each species that they enter or the member's premiums will be forfeited.
8. No use of talcum powders, oil, or other artificial coating material will be allowed when fitting or showing animals in all swine classes. Animals with talcum powders, oil, or other artificial coating material shall be disqualified. All market lambs shall be slick shorn.
9. FFA members are permitted to show the same animal in open class provided the animals being entered in open class meet the open class show requirements and we have open class exhibitors registered in the class. If there is a conflict with show times, FFA members must show in their youth class. FFA exhibits must be housed according to superintendent's direction.
10. Grand Champion Showman of a species must show the animal in which they won showmanship.
11. All Stall/pens will be stripped by Youth Exhibitors at the close of the Fair.
12. Extra handlers are permitted but must be in official dress during all fair competitions and events.
13. Fair Board Dress code:
  - 1) Shoes must be worn at all times and be flat, closed-toed shoes.
  - 2) Adequate coverage of the body is required. Halter tops, muscle shirts, exposed midriff, spaghetti straps, or otherwise revealing tops, exposed underwear and very short skirts are not permitted.
  - 3) Short are allowed as fair attire, provided that they are loose fitting and mid-thigh length. Cut-offs and bathing suits are not allowed.
  - 4) Tank tops that have wide straps and fit snug under the arms are acceptable.
14. Members may show until they turn 21 years of age, however, they cannot market past the summer of the graduation year.
15. During Livestock Judging, exhibitors may not talk to a judge except when answering a question by the judge.
16. To protest a judge's decision, the exhibitor shall submit a written statement to Fair Management within 12 hours after judging. After 12 hours, a protest will not be considered. Fair management and/or Fair Board will review within 5 business days and issue a ruling, which shall be final.
17. Judges shall not award any discretionary premiums or awards.
18. At the discretion of the judge, placing and premiums may not be awarded to animals of inferior merit even though there may be no competition.
19. Exhibitors are required to comply with all conditions outlined in this book. Exhibitors who do not comply may be expelled from the fairgrounds and may not be allowed to participate in any Fair activities and forfeit any premiums due.
20. Bedding must be provided by the Exhibitor at their own expense. The Fair will dispose of all bedding after the Fair ends.
21. **Eating is not permitted in livestock areas including the barns, show rings, and wash racks. Exhibitors may have non-glass, non-alcoholic bottled beverages with a screw top in the livestock areas.**
22. **Local exhibitors with trailers are requested to take their trailers and non-necessary vehicles home or to an off-site location for the duration of the Fair due to lack of parking space.**

23. Display and tack spaces will be assigned only if space allows after all livestock entries have been assigned. Tack and Display spaces are not guaranteed.
24. All animals are required to be on exhibit in the barns or show ring each day of the Fair during hours open to the public or specified barn hours. Superintendent has the discretion, with Fair Management approval, to release livestock prior to designated time due to illness of an animal as diagnosed by the Fair Vet.
25. Livestock will be judged only when shown in designated area and shown by the exhibitor.
26. All livestock must have registration papers from respective breed association. Papers pending accepted only in Jr. Bulls and Jr. Heifers.
27. All animals shown in-group classes must have been shown as individuals. No animal may compete in more than one class except as one of a herd, group, or championship.
28. Entries must be made for all herd and groups although individual animals comprising each group need not be named under group classification at the time of entry.
29. All animals shall be the property of the exhibitor 30 days prior to the show.
30. All bulls born before January 1, 2019 must have nose leads with nose clips or nose rings when moved on the grounds or shown. **NO EXCEPTIONS.**
31. All animals and their tack must be loaded and un-loaded at the back side of the barn or other area designated by Fair Management.
32. Aisle ways, tack areas, and exhibit areas must be kept clean and free of debris during fair hours.
33. MANURE DISPOSAL – Manure and waste handling instructions are available from department superintendents.
34. As per the Hillsboro Fire Department, the following conditions shall be met in the barn areas:
  - No Sleeping in the barns.
  - No heat producing appliances shall be allowed (Coffee Pots, Hot Plates, etc.)
  - No Smoking Signs must be installed.
  - Extinguishers shall be installed so that there is not more than 75 feet of travel distance to an extinguisher.
  - Keep all electrical panels locked at all times to restrict access.
  - Stall decorations shall be treated to be fire retardant. Documentation is required.
  - Shavings and straw shall not be stored inside of the barns. This includes Hay & Alfalfa.
  - Bedding must be kept damp throughout the day. This applies to non-milking animals only.

# ANIMAL HEALTH REQUIREMENTS

## (Provided by the Oregon Department of Agriculture)

### General Rules and Requirements

- Applies to all Livestock Programs at the Washington County Fair including Open Class, 4-H & FFA.
- No person shall bring or have present an animal on the fairgrounds during the fair which is not qualified under Oregon State animal health regulations.
- No person shall present a Certificate of Veterinary Inspection that has been altered by anyone other than the issuing veterinarian or an authorized agent.
- All animals presented that originate from a location other than within the State of Oregon shall meet all Oregon State importation regulations appropriate to the species in addition to the fair animal health requirements.
- The professional decision of the designated fair veterinarian will be upheld as final in all matters relating to animal health.

### Veterinary Health Inspections

- All animals presented for exhibition or otherwise during the Fair or Pre-Fair activities, shall be required to pass a health check by the designated Fair veterinarian(s) at a location determined by Fair Management prior to entry onto the fairgrounds.
- When presented for inspection, all blankets/hoods must be removed from animals to allow for adequate inspection. For safety reasons, cattle and horses may be required to be haltered and removed from trailers for inspection.
- Animals demonstrating clinical signs or other evidence of infectious, contagious or communicable diseases shall not be allowed on the fairgrounds.
- The designated Fair veterinarian may deny admission to or require removal from the Fair premises, or require the segregation of any animal showing signs of or exposed to any infectious, contagious, or communicable disease. The designated Fair veterinarian acting under the authority of Fair Management may reject unworthy or unsightly exhibits for reasons other than infectious, contagious or communicable disease.  
Examples of diseases or conditions which will cause animals to be denied entry or removed from the fairgrounds include (but are not limited to):
  - Club lamb fungus/Ringworm
  - Soremouth/Orf
  - Oral ulcerations
  - Pinkeye
  - Hairy heel warts/Foot rot
  - Lice
  - Skin warts
  - Erysipelas/Diamond skin disease
  - Caseous Lymphadenitis (CL) abscesses
  - Pneumonia
  - Large lacerations or other such wounds
  - Any other systemic or transmissible disease
  - Any other disease of zoonotic potential
  - Enlarged lymph nodes
- In certain limited situations, at the discretion of the designated Fair veterinarian, treatment may be provided for conditions which are not deemed to pose a threat of transmission to other animals, such as rectal/vaginal prolapse, in lieu of exclusion from the Fair. Costs for such treatment are the responsibility of the exhibitor.

## Certificates of Veterinary Inspection (CVI)

- All animals originating from outside of the State of Oregon shall be accompanied by a valid CVI, and must satisfy import health and test requirements for that species.
- The CVI must be issued by a veterinarian accredited by the USDA to perform regulatory work on the species of animal examined.
- All animals must be uniquely identified. All manmade ID must be recorded. Refer to Animal Identification section below for more information.
- The interstate CVI is valid for 30 days from the date of issuance. A change in the health status or eligibility of an animal necessitates the generation of a new CVI.
- CVI's issues within 10-days of move-in will allow the exhibitor to not have animals inspected. Anything outside of a 10-day window will require the animals to be inspected by the Vet.

## Animal Identification

- Animals requiring a CVI must be uniquely identified. Acceptable forms of unique identification include official eartag, legible registration tattoo or electronic identification (microchip/EID). A sketch or photograph signed and dated by an accredited veterinarian is acceptable identification for llamas, alpacas, and horses.
- If implantable electronic ID is utilized as the sole form of identification, the exhibitor is responsible for supplying a working electronic reader. If electronic ID cannot be read entry will be denied.
- Llama, alpaca, and horse drawings must positively identify the individual animals.
- **USDA approved scrapie identification is required for all sheep and goats.**

## Kidding and Lambing

- Due to the concern about the spread of scrapie, any sheep or goats that are exhibited at the Fair that have recently given birth or have a vaginal discharge, will be denied entry or ordered removed along with their offspring.

## Commingling of Sheep and Cattle

- Due to the potential spread of malignant catarrhal fever from sheep to cattle, it is recommended that cattle be kept separate from sheep.

## Commingling of Swine and Poultry

- Due to the potential spread of influenza viruses it is recommended that swine and poultry be housed in separate locations.

## Isolation on Returning Home

- The owner or custodian is encouraged to keep show animals biologically separate from the herd or flock for a period of at least two weeks after returning to the premises of origin.

## Individual Species Requirements

### **Cattle**

- All female cattle over 4 months of age, not exhibited solely in market classes must have been vaccinated for brucellosis. An official brucellosis tattoo including the USDA "V" shield must be visible in the animal's ear.

### **Sheep**

- All sheep must be individually identified with USDA approved individual scrapie program identification. Identification must be one of the following: 1) USDA approved ear tags or 2) a USDA approved flock tattoo and individual animal ID number or 3) electronic ID (owner must supply working electronic reader).
- If evidence of soremouth is found on any sheep, the entire exhibit including the affected animals shall immediately be removed from the fair premises with holding pens cleaned and disinfected immediately after removal.

### **Goats**

- All goats must be individually identified with USDA approved individual scrapie program identification. Identification must be one of the following: 1) USDA approved ear tags or 2) a legible registration tattoo or 3) a USDA approved flock tattoo and individual animal ID number or 4) electronic ID (owner must supply working electronic reader)
- If evidence of soremouth is found on any goat, the entire exhibit including the affected animals shall immediately be removed from the fair premises with holding pens cleaned and disinfected immediately after removal.



# LIVESTOCK EXHIBITOR CODE OF ETHICS REQUIREMENTS

1. Exhibitors at the Washington County Fair (WCF) shall at all times act with integrity and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of animal and agricultural education. This code applies to 4-H and FFA exhibitors, their parents, family members, and leaders/advisors, and all Open Class exhibitors who compete or display at the WCF. This Code of Ethics is an addition to Washington County Fair rules and regulations, which still apply.
2. All youth leaders/advisors, parents, family members, superintendents, program volunteers, and show officials working with 4-H and FFA exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. They are expected to maintain high ethical values and engage with a positive cooperative manner so that those younger and more pliable will be influenced by exemplary leaders.
3. Owners, exhibitors, parents, family members, fitters, trainers, superintendents, volunteers, show officials, and livestock persons involved in the Washington County Fair who violate this code of ethics and/or demean the integrity of the livestock competition may be subject to disciplinary action. Disciplinary action(s) may cause expulsion from participating in current and/or future WCF shows, loss of class placing, forfeiture of premiums, awards and auction proceeds.
4. Any individuals in violation of the Code of Ethics may be required to appear for a disciplinary action hearing to be held within 24 hours of the violation(s). The disciplinary hearing panel will consist of the program department superintendent, the Fair Manager, and no more than 3 Fair Board members. If applicable, a member of the auction committee and/or 4-H agent/FFA advisor may be included in the panel. The violating individual(s) may appeal the results of the hearing in writing within 24 hours of the final review by the full Fair Board at their next board meeting. The results of disciplinary actions may or may not be kept confidential.

## **The following is a list of guidelines for all WCF competitive livestock events:**

- a) The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, superintendent, volunteer, show official, or responsible person to have disciplinary action taken by the WCF for violation of this Code of Ethics and any other policies, procedures, or rules of the WCF show without recourse against the WCF.
- b) The act of entering an animal at the WCF is the giving of verification by the owner, exhibitor, fitter, trainer, superintendent, volunteer, show official, or responsible person, that he or she has read the WCF Code of Ethics and understands the consequences of and penalties provided for actions prohibited by the code.
- c) All exhibitors must present, upon request of WCF officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age or any related facts is prohibited.
- d) Owners, exhibitors, fitters, trainers, or responsible persons shall provide animal health certificates from licensed veterinarians upon request of WCF officials.
- e) 4-H and FFA animals are expected to be cared for, groomed, and fitted by their exhibitors while at the WCF.
- f) For animals entering the food chain, (market animals): Animals will be free of prohibited drugs and subsequent residues. Animals shall be presented at show events as if they were to immediately enter the food chain. Any drug that alters and/or affects the animal's performance or appearance is strictly prohibited.
- g) Livestock shall not be exhibited even if these types of drugs were administered in accordance with federal, state and local statutes, regulation and rules.
- h) The act of entering an animal in livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the to be used in testing.
- i) If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be evidence such substance has been administered to the animal either internally or externally.
- j) Integrity of fluid collection samples and assumption of laboratory accuracy: It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden of the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.
- k) Any time after an animal arrives on the WCF premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian, the direct owner of the animal, or a qualified individual under the supervision or with consent of the owner.
- l) Animals entered in an event which does not culminate with the animal entering the food chain (breeding only) shall not be administered drugs other than in accordance with applicable federal, state and local statutes, regulations and rules.

- m) Any surgical procedure or injection of any foreign substance or drug, or the external application of any substance, which could affect the animal's performance or alter its natural contour, conformation, or appearance, is strictly prohibited. This includes, but is not limited to: irritants, counterirritants, or similar substances; this excludes; external applications of substances to the hoofs, horns or coat (in accordance of show rules), and the administration of substances during surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal.
- n) The use of handling devices that strike animals and cause swelling are not acceptable and are prohibited.
- o) Direct criticism or interference with the judge, WCF management, other exhibitors, breed representatives, or show officials, before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, WCF management, or other show officials, shall be treated with courtesy, cooperation and respect. No person shall direct abusive or threatening conduct toward another.
- p) No owner, exhibitor, fitter, trainer, or responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics.

## **POLICY AND PROCEDURES FOR MANAGING LIVESTOCK CONTACT**

The Washington County Board of Commissioners has entrusted the Fair Board to give priority for the personal safety and security of members of the public who attend the Fair, as well as those who work and participate at the Fair. The Fair Board takes this matter seriously and has established the following policy and procedures for Fair Staff and Livestock Exhibitors in an effort to reduce transmission of diseases from animals to humans at the Washington County Fair.

### **1. Expectations and Procedures to Reduce Contamination**

- Livestock Exhibitors may be required to participate in Bio-Security training prior to exhibiting Livestock at the Fair. This training shall be conducted, at least once per year, by Washington County Public Health and the Fair Manager. If a livestock exhibitor fails to participate in Bio-Security training, the exhibitor may lose premiums and eligibility to participate at the Fair.
- To reduce the potential risks between animals and the public, County Fair staff, under the direction of the Fair Manager, shall set up the livestock barns, pens and show rings in a manner that prevents animals and the public from crossing paths yet still gives the public the opportunity to see and interact with the animals and the exhibitors. The Fair Manager shall gather input from Livestock Superintendents on layouts and make the best decision based upon this input, and other factors such as the number of animal entries, to minimize animals/exhibitors and the public from using the same pathways. If needed, a crossing area where animals are allowed to cross the public pathway shall be designated and managed by Fair Staff who shall ensure that during livestock crossing the public will not be allowed into the area and the area will be completely sanitized (Chemical SDS will be posted), and logged, prior to opening the area back up to the public.
- County Fair staff shall provide the following signage, in languages including but not limited to English and Spanish: (1) signs explaining the risks of animal-to-human disease at the entrances to the Fair and the Livestock barn areas; and (2) signs in the barns and showrings reminding the public to not eat or drink in the livestock areas, to not touch their face or mouth after petting the animals or touching the pens, to wash their hands when leaving the livestock area, and to store all personal belongings in plastic zip lock bags that will be provided by the Fair prior to entering the livestock area.
- County Fair staff shall provide an adequate number of handwashing trailers throughout the livestock area. These handwashing trailers shall be ADA-compliant and accessible by small children. Handwashing trailers shall be inspected and serviced hourly by Fair staff to ensure that they are operational and stocked with supplies. When possible, handwashing trailers should be staffed with volunteers to encourage the public to wash their hands. Handwashing trailers shall be located at the entrance/exits to the livestock area including next to the Dairy Women's Ice Cream booth. To encourage handwashing and shoe and stroller sanitization prior to leaving the livestock area, the handwashing trailers shall be located as close as possible to the walkways where the public will be exiting the livestock area.

- If available, trained public health volunteers shall be stationed at the entrances to the livestock areas to educate the public on staying healthy around animals. These volunteers shall provide plastic bags to store food, beverages, pacifiers, toys, cups and other items during visits to the animal areas.
- Exhibitors shall keep their areas in the barn clean, remove manure from their pens and animal pathways as soon as possible, wipe down panels that are accessible by the public with disinfectant several times during each day, keep animal pathways misted to prevent dust, keep all fans that are used to keep the animals cool at least 3 feet off the ground and position the fans airflow to prevent the creation of dust or movement of the bedding. Fair staff and exhibitors shall work together to keep public spaces in the barns, showings, and other livestock areas clean.
- Exhibitors shall clean or change their shoes and wash their hands before leaving the barn/showing areas to prevent contaminating public areas. Chemical SDS shall be posted for cleaning supplies.
- When the public touch the animals, the animal pens, and/or animal bedding, the exhibitors shall remind the public to wash their hands with soap and water and to not touch their face or mouth until they have completely washed their hands. This is the perfect time to provide public education regarding the importance of animal-to-human safety.
- Consumption of food and beverages are strictly prohibited inside the barns and show rings for the public and exhibitors. Due to the heat and the amount of time exhibitors spend in the barns, exhibitors may drink beverages as needed from containers with a twist off cap while in the barns and show rings.
- The milking parlor, animal washing areas, and the backsides of the barns shall be completely blocked from public access and public pathways.

## 2. Communication to Exhibitors

- The Fair Manager shall work with the Oregon State University 4-H Extension Agent and Future Farmers of America Advisors to arrange for information to be provided to youth livestock exhibitors and their parents regarding these policies and procedures, trainings, and other pertinent livestock exhibitor information regarding the County Fair at least 3 months prior to the first day of the Fair.
- For Open Class livestock exhibitors, information regarding these policies and other pertinent livestock exhibitor information shall be posted on the Fair website at least 3 months prior to the first day of the Fair.

## LIVESTOCK EXHIBITOR CAMPING INFORMATION

- A campground is available for use by registered Washington County Fair Livestock Exhibitors only.
- Advanced online registration, online credit card payment and acceptance of the rules of the campground is required.
- Registration and rules can be found on the Fair website [www.bigfairfun.com](http://www.bigfairfun.com) under the Livestock Exhibitors section.
- Anyone found violating the campground rules may be expelled from the campground.

## ADMISSION AND PARKING INFORMATION

- Admission to the Washington County Fair is free. Registered Livestock Exhibitors who wish to access the Fairgrounds via the Livestock Gate must have Fair issued identification which is available at the Fair Complex Customer Service Window starting the Monday before the Fair at 8:00 a.m. to 6:00 p.m. The last day to pick-up the identification will be at 6pm on the day before the Fair opens. Photo ID is required to pick-up.
- Parking at the Fair Complex is \$10 per car, per day, and space is limited and not guaranteed. These lots will fill up. The Fair encourages exhibitors to carpool or ride the MAX train when possible. Parked vehicles may come and go with that day's ticket. Any vehicles left in non-reserved parking lots overnight may be towed.
- There will be a limited number of reserved parking spaces located near the livestock entrance gate for sale for \$60 for the week exclusively available for registered livestock exhibitors. This option will give the purchaser peace of mind knowing they have a guaranteed spot.. See [www.bigfairfun.com](http://www.bigfairfun.com) for purchasing.
- Trailer Parking Lot - This lot is reserved for livestock trailers and tow vehicles that do not need to come and go at no cost to the exhibitor. Priority will be given to livestock exhibitors from out of the area. Local exhibitors are requested to take their trailers and non-needed vehicles home after unloading at the Fairgrounds on move-in day. If an exhibitor needs their tow vehicle to come and go from the Fairgrounds, it can't be parked in this lot. This lot will be locked beginning Thursday morning July 25, 2019 at 10:00 am and will remain locked until Sunday, July 28, 2019. Staff will coordinate with Livestock Superintendents for unlocking of this lot for livestock move-out on Sunday.

## MASTER SHOWMANSHIP RULES

- In order to participate in the Master Showmanship contest, you must have won grand champion showman in your showmanship class. If an exhibitor has won multiple grand championships, exhibitor must pick one species to compete in the Master Showmanship contest. The reserve grand champion will then compete in the Master Showmanship contest for the other species not chosen by the grand champion.
- The Master Showmanship contest is only for those FFA members who are currently attending high school and for the graduating senior, following the summer of their graduating year.
- For those FFA members who have graduated one year or more but are under the age of 21, we will have a College Master Showmanship contest if there are at least four exhibitors.
- Five species of animals will be shown in the Master Showmanship contest. The species exhibited will be determined by the five species with the most individual exhibitors. This is subject to change at the advisor's discretion based on availability of animals of similar size, age, breed, type, etc. Master Showmanship participants are asked to help locate the five animals that will be used as well as helpers to hold/move animals between rotations.
- All five Master Showpersons will show the same species at the same time. A rotation will be announced ahead of time, and all five participants will rotate together. Approximately 12 minutes will be allowed per rotation with 3 minutes to rotate to next species.
- Master Showmanship participants will be judged on their ability to show/present the species, as well as their ability to answer questions asked by the judge. Fitting of the animal WILL NOT be included in the placing. Showpersons WILL NOT exhibit their own animal.
- Judges are selected at the discretion of the advisors.
