## WASHER TOURNAMENT

### **TEAM PLAY RULES**

Friday, April 24th @ 6:00 p.m. CCC/GYM

#### **CONTEST FORMAT**

Each player will have three washers and will pitch from behind a line that is perpendicular to the long dimension of the court. This line will run through the center of the cup from which the participant is pitching. A coin, tossed by the court official, will determine which team will pitch first. Thereafter, the team that scores the previous point or points will pitch first.

#### **SCORING**

For a washer to score points, the washer must fall within 12" of the cup. This 12" is measured from the inside edge of the cup. The entire washer does not have to be inside the 12" mark to count. Should all washers on a given pitch fall entirely outside the 12" limit, no points will be awarded. The contestant who pitches first throws all of their washers and is then followed by their opponent. Only one team scores points on each set of pitches. This is determined by the player with the washer closest to the cup (within a 12" radius), on the edge of the cup, or in the cup that is not canceled by an opponent's washer. If a washer is thrown and comes to rest in the cup, it is called a "ringer" and has a value of five points. A pitch whereby the washer comes to rest with any portion of the washer extending over the inside edge of the cup is called a "leaner" and has a value of three points. If a washer lies within 12" of the cup and is not a ringer or a leaner the scoring is as follows: The contestant with the washer closest to the cup scores one point. If the second and third washers lie within 12" and are closer than the opponent's washers, they score one point each. Point values are canceled in the case where opponents match ringers and/or leaners. (A leaner by one player cancels a leaner by an opponent regardless of the amount each washer extends over the edge of the cup.) The next closest washer determines who scores.

Careless or reckless play will result in disqualification.

#### **ELIMINATION ROUNDS**

Games are played until one team scores at least 21 points. Exceeding 21 points does not constitute a penalty. Should one team score 11 points before the other team scores any points, a "skunk" is declared and the team with 11 points is named the winner. All games are limited to 10 minutes. If time is called and neither team has reached 21 points, the team with the most points is named the winner. Each of the teams will play the best two out of three matches as designated by the scorekeeper. First round byes will be drawn at random by the scorekeeper. The first go-round will be the best two out of three games with the winning teams advancing in the Winners Bracket. Teams losing their first match will move to the Elimination bracket. All matches in the elimination bracket will be a single game match. Skunks will be allowed in all rounds except the championship rounds. An 11-0 skunk will be scored as a 21-0 score. The winner of the elimination bracket will place third in the respective contest.

#### 2020 WHARTON COUNTY YOUTH FAIR RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

In consideration, the receipt and sufficiency of which is hereby acknowledged, for being allowed entry into and participation in activities (the "Activities") associated with the Wharton County Youth Fair & Exposition, the undersigned hereby enters into this RELEASE OF LIABILITY AND INDEMNITY AGREEMENT (this "Agreement) as of the date set forth below.

ACKNOWLEDGMENT OF RISKS: The undersigned recognizes and understand that there are risks associated with their participation in the Activities including, but not limited to, bodily injury or death to persons and damage to property. The undersigned further acknowledges and understands that they and/or any persons (including, but not limited to, minors) under their care and control, and that arise out of, or are related to, the undersigned's entry into and participation in the Activities.

APPLICABILITY AND SCOPE OF RELEASES AND INDEMNITIES: for purposes of this Agreement, "Claims" shall mean any past, present and future claims, losses, costs, expenses, liabilities, demands, or causes of action, and costs of defense or settlement (including, without, limitations, attorneys' free and court regardless of whether the Claims to be release, waived, or indemnified against arise, or are alleged to arise, from(i) NEGLIGENCE(WHETHER SOLE, JOINT OR CONCURRENT), Gross NEGLIGENCE, NEGLIGENCE PER SE, and/or STRICT LIABILTY, of the Wharton County Youth Fair & Exposition or its present and former officers, directors, members, subsidiaries, affiliates, employees, volunteers, staff, and/or agents and any other person, firm or corporation bound to defend or pay judgments against them(the "Released Parties"); (ii) personal injury, death or property damage; (iii) acts under the Texas Deceptive Trade Practices Act("DTPA"); (iv) acts of any other persons or guests; (v) theft, burglary, assault, or other crimes; (vi)fire, water, wind, rain and/or smoke and/or(vii)any other risks and hazards associated with the undersigned's entry into and participation in the Activities, including, but not limited to, the general conditions at the Activities, animals both wild and domestic that may be diseased and/or potentially dangerous, persons with firearms both on and off the premises used in connection with the Activities, and the driving or riding in any vehicles, whether belonging to Released Parties or to other persons.

**RELEASE FROM LIABILITY:** The undersigned hereby RELEASES, ACQUITS AND FOREVER DISCHARGES, and WAIVES any and all Claims against any of the Released Parties that arise from or relate to their entry and participation in the Activities- including, but not limited to, the types of claims enumerated in Parties shall not be liable to them, their family, or their guests, for personal injury, property damage, or any other Claims arising from or related to the undersigned's entry into and participation in the Activities.

AGREEMENT TO INDEMNIFY AND HOLD HARMLESS: The undersigned agrees to INDEMNIFY and HOLD HARMLESS the Released Parties against any and all Claims arising from or related to the undersigned's entry and participation in the Activities – including, but not limited to, the types of Claims enumerated in minors under their care and control and/or his or her parent/guardian, and for any Claims asserted by, through or under the undersigned, arising from or related to the undersigned entry into and participation in the Activities- including, but not limited to, the types of Claims enumerated in Paragraph 2. As used herein, "INDEMNIFY "means to agree to assume the Released Parties' liability in a situation, thereby relieving them of responsibility, and/or reimbursing the Released Party for Claims asserted against them.

PHOTOGRAPH INTERVIEW RELEASE AND INDEMNITY AGREEMENT: The undersigned GRANTS PERMISSION to be PHOTOGRAPHED or INTERVIEWED in connection with the Activities. The undersigned understands that any such photograph or interview may be used by the Release Parties or television, film video, visual, graphic or printed media. The undersigned agrees to RELEASE and INDEMNIFY the Released Parties with respect to any Claims related to the usage of such photographs or interviews by the Released Parties or any media — including, but not limited to, the types of Claim's enumerated in Paragraph 2.

As further inducement to the Wharton County Youth Fair & Exposition to permit the undersigned's entry into and participation in the Activities, the undersigned represents that they thoroughly and completely understand that this a complete and final release and indemnity agreement, that they are freely and voluntarily entering into this Agreement, and that no representations, promises or statements made by and Released Party, or any agent, attorney or other representative of any Release Party has influenced the undersigned in causing them to sign this Agreement.

The undersigned understands that this agreement shall be binding on their heirs, executors, successors and assigns, that the Agreement will be governed by the laws of Texas, and that jurisdiction and venue for resolution of any dispute regarding this Agreement shall lie in a Texas State Court in Wharton County, Texas. If any part of this Agreement is determined to be invalid or unenforceable, it does not affect the validity of the remainder of the Agreement. The undersigned agrees to the terms and conditions above, and acknowledges receipt of the Agreement.
