Pre-Entry: Entry form is due in the Fair Office by Friday, August 2nd, by mail or in person.

Rules & Regulations:

- All contestants must be full time residents of Williamson County.
- All contestants will receive a beautiful rhinestone crown and a rose.
- Each contestant must reach her 16th birthday, but not her 21st birthday, by December 31, 2018. The Fair reserves the right to require proof of age upon request.
- Interviews will be held at the Performing Arts Center at Academy Park, Franklin, beginning at Noon. Interviews are 3 minutes long. Please wear your interview suit or dress.
- All contestants must never have been married, had a child, been arrested, or convicted of a felony.
- Sportsmanship and manners are required of all contestants.
- Dress Guidelines: Pageant dresses are formal and floor length. Interview suit or dress for interview competition. Interview dress will also be worn at the beginning of the pageant that evening for introductions on stage at a microphone.
- The judges' decision will be final. No refunds will be given.
- Interviews will be held at noon on the same day of the pageant at Academy Park, will be 3 minutes long, and count 25% of total score. Beauty, Stage Presence, and Overall Appearance each count 25% for a total score of 100%.
- Only one chaperone is allowed in the dressing room with the contestant.
- The Winner must be able to represent the Fair at different events during the week of the fair, and throughout the year. She is also expected to attend the Tennessee Association of Fairs Convention in Nashville, in January 2020. If she cannot attend the State Fairest of the Fair Contest, she must relinquish her crown to the 1st Runner-up who will then become the new Fairest of the Fair. The Williamson County Fair will furnish room and board plus \$200.00 for expenses at the State Contest.
- A Modeling Workshop will be held on Saturday, August 3rd, 3:00-5:00 pm at the Performing Arts Center at Academy Park for all contestants to practice walking on the stage. Attendance is not mandatory.
