Park Rules, Regulations, and Policies

1. Pursuant to the California Recreational Vehicle Occupancy Law, the "Recreation Vehicle may be removed as specified in Section 799.22" for failure to pay or failure to comply with park camping policy.
Civil Code Section 799.22, 799.43, and 799.58
2. We accept 2005 or newer RVs: class A, B, & C motor homes, travel trailers, and 5th wheels. All RVs must be self-contained with 3" sewer hose. Hence forth RV will stand for any of these types of vehicles.

3. All renters and guests shall acknowledge receipt and sign our fairgrounds RV/Camping contract, which includes the "park rules, regulations and policies" prior to parking the RV on our site. Failure to do so will result in being requested to immediately vacate the RV Park.
4. We do not allow Drop Offs or Tow Ins. All RVs, trailers, and other camping style vehicles must have current valid DMV registration this includes the tow vehicle as well.
5. RV and guests must adhere to a code of good conduct and behavior while on the Fairgrounds. Do not disturb the other park residents, and or participants and guests of other fairgrounds activities. No loud and or continuous noises, music, barking dogs, verbal obscenities and or parties.
6. RV park fee is \$35 per night per RV parked on the Fairgrounds.
7. RV parking is only available for a maximum of 2 continuous weeks (14 days). Maximum annual stay is 28 days.
8. Only 1 RV per space and only 1 extra vehicle (car, pickup) associated with the RV allowed.
9. RV space must be maintained in good, clean condition and no garbage visible.
10. No vehicle repairs, maintenance activities, fluid changes, washing or rinsing of vehicles or RVs are permitted in the park.
11. The 40th District Agricultural Association (Yolo County Fair) is not responsible for theft and/or damage incurred to vehicles and or other property while parked on the fairgrounds.
12. RV fees must be paid upon arrival or by noon to the kiosk in the park or online at www.yolocountyfair.net
13. Dogs and or other pets must be on leash when outside your RV. If dogs and or other pets are noisy or left unattended, owner will be asked to leave facility. You must clean up after your dogs and or other pets.
14. Parking for RVs is restricted to assigned areas only. All property must be in the confines of the assigned space. Main RV area contains 40 full service hook ups. No restroom or shower facilities.
15. Check out time is 1:00 p.m. the day following your last night paid.
16. Bicycles, roller blades, skates, scooters, skate boards, golf carts or ATVs are prohibited anywhere on the fairgrounds.
17. Illegal drugs, firearms, and or any other type of weapons are prohibited anywhere on the fairgrounds.
18. Speed limit is 10 mph in the RV Park and inside fairgrounds area.
19. Management reserves the right to make changes deemed necessary in these regulations. We reserve the right to refuse services to current and returning guests that have violated our rules and regulations and or have vacated the park without paying all fees.
20. Management reserves the right to tow at the Owners Expense any RV or Vehicle that is in our park for nonpayment or for violation of our Rules & Regulations.
