Dear Outdoor Concessionaires:

The 2019 Fond du Lac County Fair is right around the corner. The fair board has been working hard to plan our 168th annual Fair! This year the fair dates are **July 17-21, 2019**. We would like to invite you to be a part of our Fair this year.

The Fair will feature several new additions as well as numerous time-honored traditions this year. We will again offer FREE general gate admission to ALL fairgoers. The outdoor concessionaires spoke positively about impact this change had on the 2018 attendance. Visit our website for our complete event line-up as it is released. The sea lion show has confirmed their commitment to our event again. This will be a great draw to the grounds!

The Fair will again charge a commission fee in addition to the footage we are charging. This revenue source helps the fair to continue to sign new acts like a sea lion show, family entertainment, and bigger grandstand acts that will increase attendance and sales for all vendors on the grounds.

Here is an example of how the commission charge would work:

You have a 15-foot stand @ \$48/foot = \$720 space rental.

You will report sales by 2pm the day after (Wednesday sales will have to be reported by 2pm Thursday) Commission will not be owed until you have sales that surpass your footage fee.

Total Commission owed to the Fair = \$146.00

The board is committed to again supporting a business lunch program for local businesses. This program will encourage local business to send their employees to the grounds for lunch Wednesday through Friday. This promotion is in its second year with the hope of expanding. Further information will be provided as it develops. Again, this extra work is in a continued effort to increase traffic to the grounds for both your sake and ours.

There are no layout changes planned to the grounds and vendor contracts for 2019. Please be sure to indicate which connection type of electricity your campers and stands need.

Please take the time to read through the remainder of this letter, the rules and regulations, and the contract. Your signature on the contract binds you to all the items in this letter and the contract whether you read them or not!!

- All food concessions will be inspected and assessed a fee for a permit by the County Health Department. Be advised that FDL County sets the fee they charge and that the fair board has no control over this fee.
- Please fill out all the necessary information requested on the contract and read it thoroughly.
- You MUST submit a COMPLETE menu of all food items you wish to sell. Once your contract is received and your menu is reviewed, you will receive a confirmation email indicating which items you may sell. Food item approval will be granted on a first come first serve basis with grandfather rights granted to vendors that have attended our Fair in the past. Items not on your approved food list will not be allowed to be sold at the fair. If you do not submit a menu, the items you wish to sell may be limited. Refunds will not be given on rental contracts due to menu item disputes.
- You will receive receipt of payment and a menu confirmation from me after your contract is received and accepted.
- A DEPOSIT OF 30% OF YOUR CONTRACT TOTAL AMOUNT MUST ACCOMPANY YOUR CONTRACT! The balance of contract must be received 2 weeks prior to the fair if paying with a check. Balances paid by cash or credit card will be accepted BEFORE you set up and open for our fair. Credit Card Payments are subject to a 3% processing fee.
- Your vendor packets which include your parking tickets, space location, camping location (if applicable), and payment receipt can be picked up during the following designated set-up times:
 - Monday July 15 from 8:00am to 6:00pm.

- Tuesday July 16 from 8:00am to 6:00pm.
- All vendors will be required to sell soft drinks and water in 20-oz bottles or cups. ONLY beverage products from the Coca-Cola representative will be allowed to be sold at the Fair. ALL beverages to be sold must be purchased from the Fair. Absolutely no carry-ins of beverages for resale will be allowed. Failure to comply with this rule will result in a \$250 fine, potential loss of space in future years, and forfeiture of beverage selling privileges. Your beverage bill must be settled before leaving on Sunday. Distribution of soft drink and water product will still be handled on site by the distributor. Product prices are as follows: 20oz bottles soda/sports drink \$28/case, 20oz Dasani water \$17.50/case, 5 Gal BIB \$100.00, 2.5 Gal BIB \$55.00, CO2 \$35.00.
- There will be a new process for ice on the grounds. This process is being worked out currently but you will have information on how that process will operate in your vendor packet.
- Outdoor Vendors MUST REMIAN SET UP AND OPEN until 8pm on Sunday. Failure to do so will negatively affect future contract eligibility. With the implementation of a business lunch there will be a mandatory open time of 11:00AM on the grounds.
- Distribution of Coca-Cola products will be available daily.
- Sponsors and certain volunteers/partners of the Fair will be given wooden tokens redeemable for food or beverage purchase at the fair. If you chose to accept these tokens for payment, no change is to be given on the sale. The tokens can be turned into the fair office daily with your commission report to be used for commission payments. Any extra tokens turned in will be paid to the vendors by the office on Sunday.
- If you plan to camp on the grounds during the fair, please complete the camper registration section on your contract as sites fill up quickly.

Again, welcome to the Fond du Lac County Fair. We hope this year is very successful for you. If you ever have any questions do not hesitate to contact Lisa Immel.
