

Enter the Pallet Art Contest at the 2020 Fond du Lac County Fair!

For an entry fee of \$5.00, which shall be paid with the registration form, each Exhibitor may enter only one item into the Fond du Lac County Fair Pallet Art Contest. An exhibitor can be an individual or a group (ex. 4-H Club, FFA, etc.) This Contest is open to children and adults. Prize money will be awarded in 3 divisions: child, adult, and group.

The items will be judged based on originality, design, aesthetics and craftsmanship. Pallets may be decorated, painted and/or repurposed.

Requirements:

- the size can be no larger than a pallet (maximum size 50" x 50" x 12" thick
- entry must be completed by the exhibitor (individual or group)
- entry must be family appropriate and incorporate the 2020 Fair theme: Kickin' It
 Up
- exhibitors are responsible for obtaining their own pallets
- 90% of the structural material must be composed of wood from used pallets

Entry forms and fees can be mailed to the Fair Office PO Box 1466 Fond du Lac, WI 54936 or dropped off at the Fair Office no later than 4:30pm on July 3rd. Exhibitor shall bring their entry to the Fond du Lac County Fair Office by Friday, July 10th at 4:30pm. Judging will take place Wednesday, July 15th during Open Class Judging. Items will be displayed in the Recreation Building during judging and throughout the duration of the Fair and can be picked up after 6PM on Sunday, July 19th. If you are unable to take your entry at that time, arrangements for pick-up should be made at the Fair Office.

**This Contest is separate from Jr. & Open Class Entries. An item entered in Jr. or Open Class is not eligible for this contest. **
