**Outside Spaces:** Spaces are sold by the front foot, in five-foot increments, with a minimum of ten front feet. Most outside spaces have a depth of 20 feet. Outside spaces can be for Food Concessions, Commercial Exhibits, Non-Commercial Exhibits, Farm Machinery, Outdoor Recreation Equipment, or Power Equipment Displays.

**Novelty Rate is \$65.00 per front foot for non-food sales and jewelry.** Corner spaces are an additional \$75.00 fee. Depth over 20’ is charged at ½ the front foot lease rate, if available. *Rates are subject to change.*

All applications go through a screening and approval process conducted by Fair Management. Fair Management has the right to accept or deny any application and/or items or services being sold, exhibited, promoted, or given away. The Fair attempts to select vendors who will complement the other products and services booked and what Fair Management believes will appeal to the Fair Attendee. The Fair strives to provide Fair patrons with exposure to exhibitors/concessionaires who provide quality products or services; therefore, it is very important to have a professional display.

**NOTE:**

**Buncombe County Environmental Health requires a \$75.00 fee per each Temporary Food Establishment due 15 days prior to inspection day. Subject to change.**

**Insurance Requirements**

**All concessionaires and exhibitors** participating in the N.C. Mountain State Fair are required to provide a certificate of insurance showing General Liability Insurance with a minimum of \$1,000,000.00 per occurrence. The company must be licensed to do business in the State of North Carolina and the certificate must be countersigned by an agent of record approved by the Commissioner of Insurance, State of North Carolina. The certificate must name **the N.C. Mountain State Fair as Additional Insured. This Certificate is required after a contract is written. This form is an application only.**

Product Liability Insurance is required of Food Concessions or Commercial Exhibitors selling or giving away any consumable food or drink product and those who have products that are applied to the skin. This includes but is not limited to lotions, magnets and services such as blood pressure checks and chiropractic procedures.

Farm Equipment is subject to availability at management discretion.

The Commercial Equipment Rate is \$1.00 per square foot; ex. Autos, ATVs, construction equipment. Minimum of 200 sq feet.

**Electrical Hook-Up is Optional. The electrical rate is: 20 AMP-\$100.00**

**30/50 AMP-\$150.00 Single phase over 50 Amp is subject to availability with a minimum of \$200.00.**

**All electrical connections are per connection. Rate is subject to change.**
